<p>If the Applicant is not subject to an existing agreement with the City of Hamilton defining relocation cost distribution for the Equipment installed under this permit, the following shall apply:</p> <p>The Applicant agrees that the relocation costs of Equipment installed as permitted are distributed as follows: Within four years of its installation, the Municipality shall reimburse the Company for 100% of its relocation cost of such Equipment, provided it is installed in the approved locations; and thereafter the Municipality shall reimburse the Company for its relocation cost of such Equipment based upon the following chart:</p>
