EXECUTIVE SUMMARY:

Appointment to the Barton Village B.I.A.'s Board of Management.

BACKGROUND:

The Board of Management of the Barton Village B.I.A. elected Tom Giornofelice to its Board of Management at its meeting held March 1.

The Barton Village B.I.A.'s constitution dictates that the Board of Management will consist of a minimum of 7 Board members not including the Ward Councillors. The appointment of the above individual brings the number of Board members to 7 not including the Ward Councillors; such an appointment therefore is in accordance with the Barton Village B.I.A.'s constitution.

Section 204 Subsection (12) stipulates "...if a vacancy occurs for any cause, the municipality may appoint a person to fill the vacancy for the unexpired portion of the term and the appointed person is not required to be a member of the improvement area".
