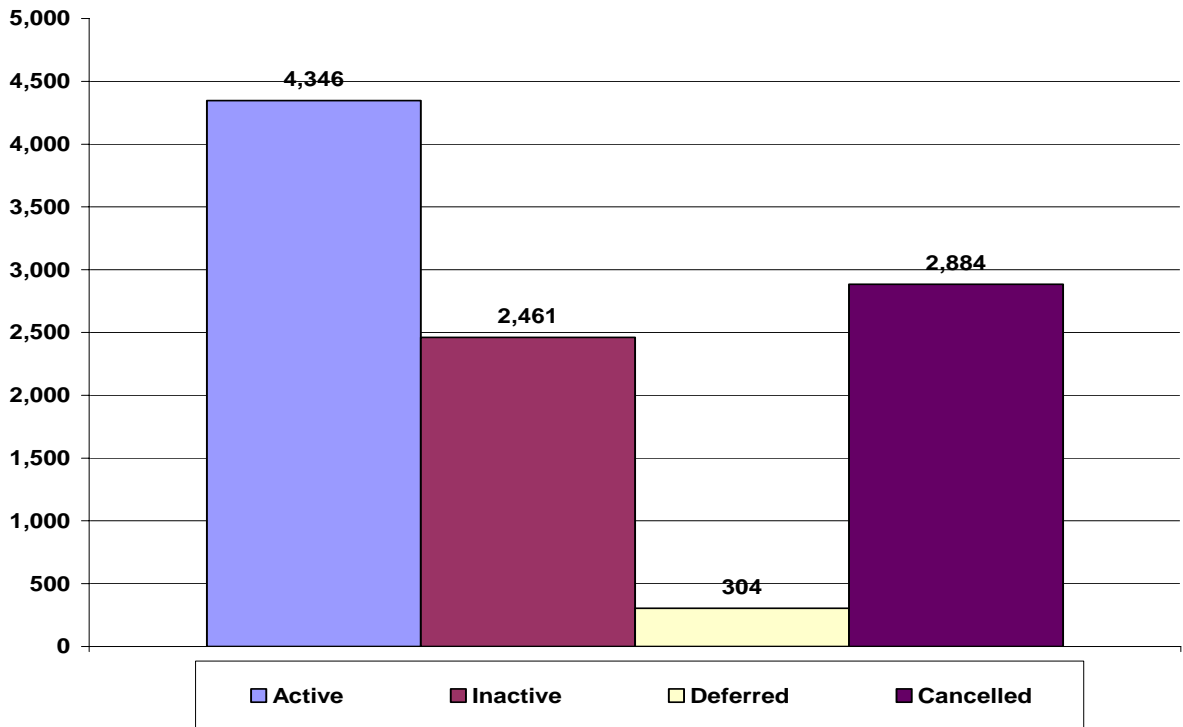


SUMMARY OF WAIT LIST FOR SOCIAL HOUSING

as of March 31, 2006**

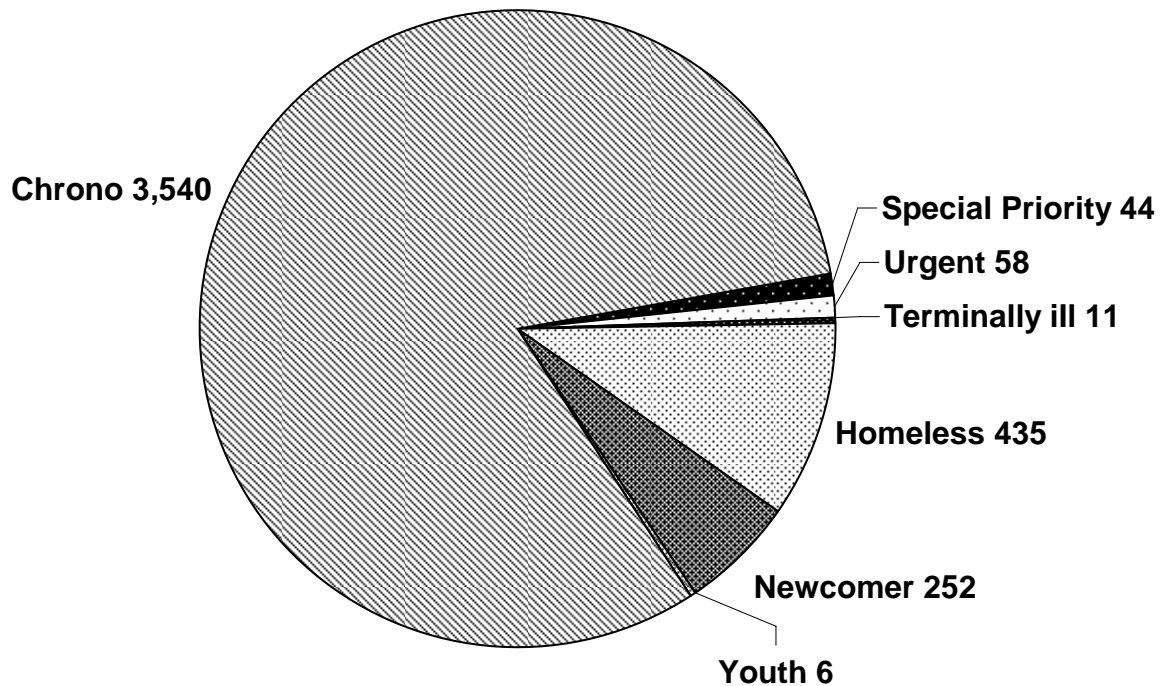


Definitions

Active:	Application is in good standing
Inactive:	An applicant has not responded to an ATH update, therefore the applicant's file is made inactive. If the applicant does not contact ATH within 12 months, the application will be archived
Deferred:	An Applicant may defer their application for housing for any reason and for any length of time
Cancelled:	The Application has been either been cancelled by the applicant, or by ATH as the applicant is no longer deemed eligible for social housing

Applicant Status as of March 31, 2006**

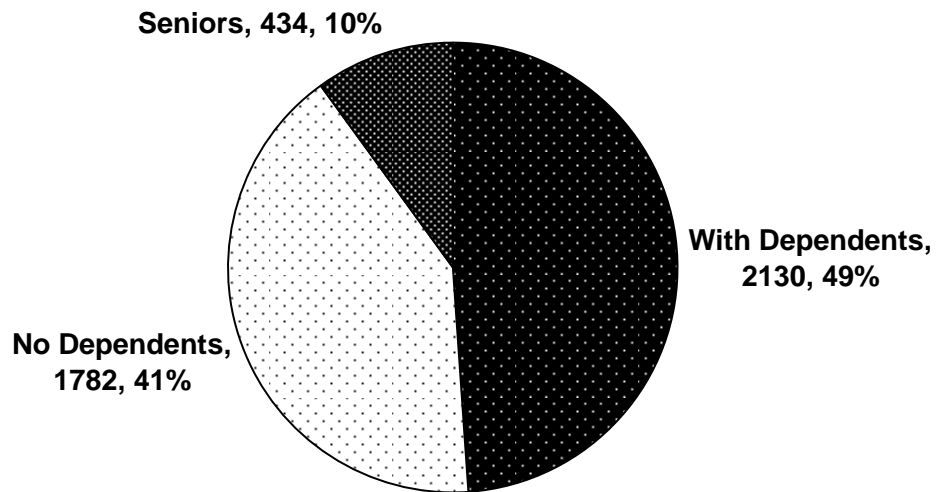


Definitions

Special Priority Status:	As per the SHRA, Special Priority Applicants are placed at the top of the waiting list (1 st pick)
Urgent Status:	This is a local rule; after Special Priority Applicant's, applicants with Urgent Status will be placed next on the waiting list (2 nd pick)
Terminally Status:	This is a local rule; after Special Priority Applicant's, along with Urgent Status applicants, applicants who are Terminally ill will be placed next on the waiting list (2 nd pick)
Homeless:	1 out of every 5 th offer of housing will be made to applicants with Homeless Status
Newcomer:	Applicants who have been living in Canada for less than one year will be given Newcomer Status and will retain this status until housed. 1 out of every 10 th offer will be made to applicants with Newcomer Status
Youth:	16 and 17 year old applicants. 1 out of every 10 th offer will be made to applicants with Youth Status
Chronological:	Applicant has been placed on the ATH waiting list in order of their application date

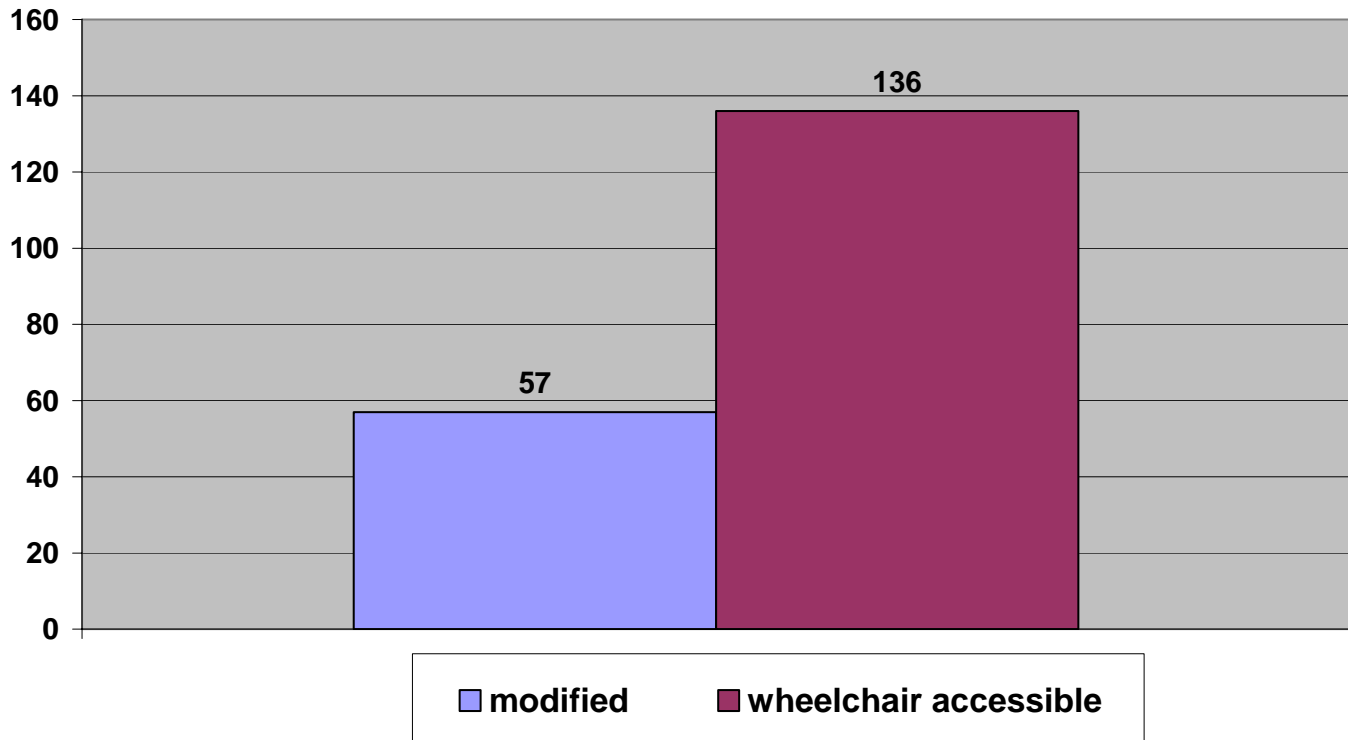
SUMMARY OF WAIT LIST FOR SOCIAL HOUSING

As of March 31, 2006**



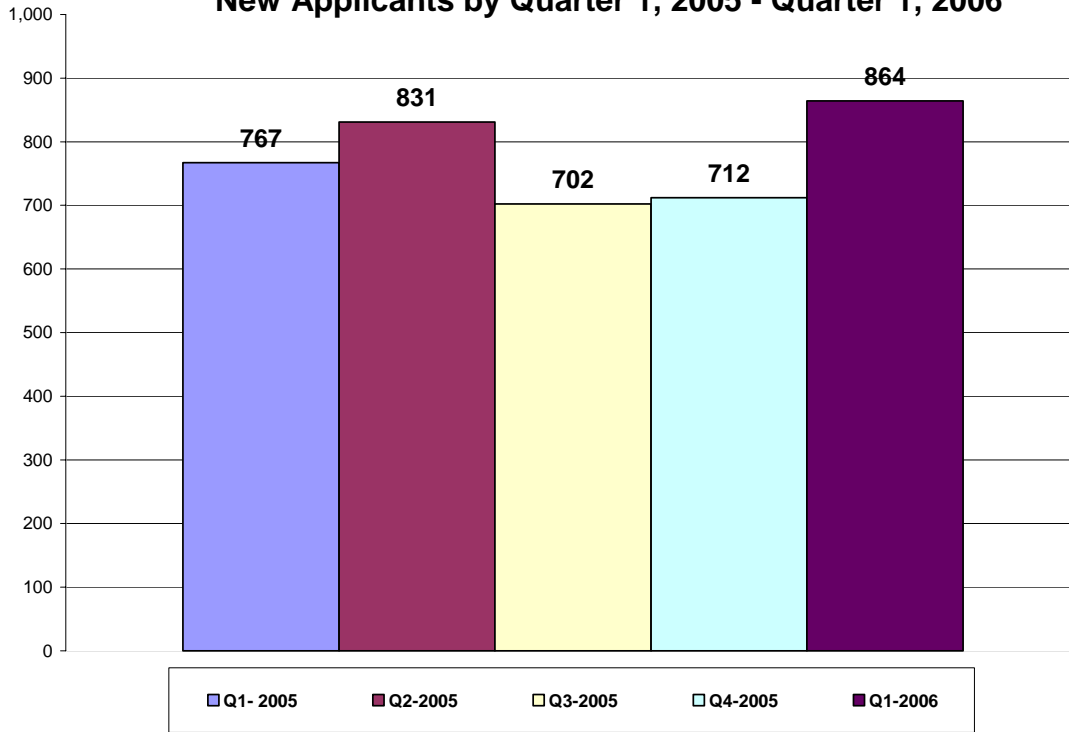
SUMMARY OF WAIT LIST FOR SOCIAL HOUSING

As of March 31, 2006**

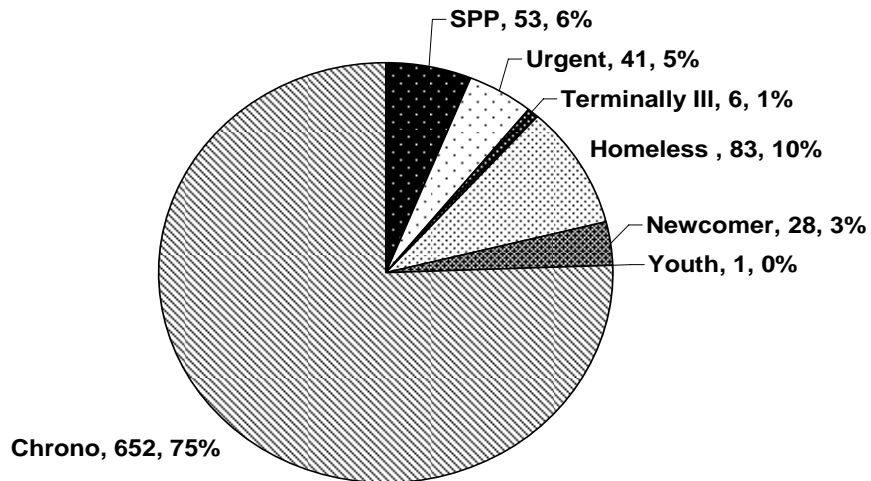


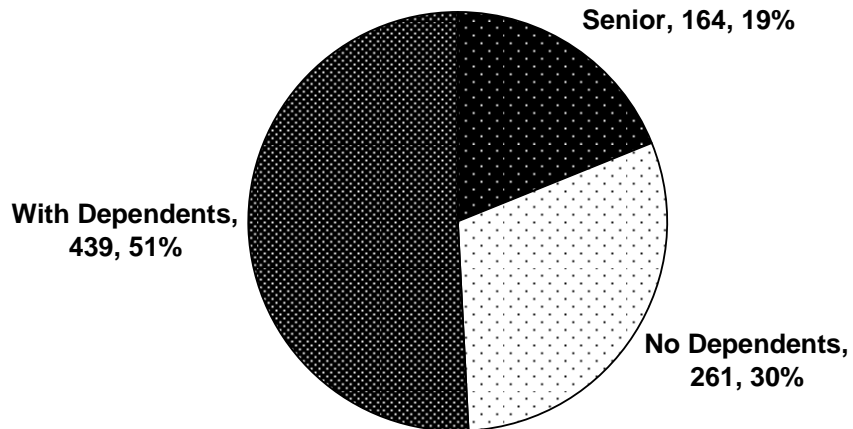
SUMMARY OF NEW APPLICANTS

New Applicants by Quarter 1, 2005 - Quarter 1, 2006**



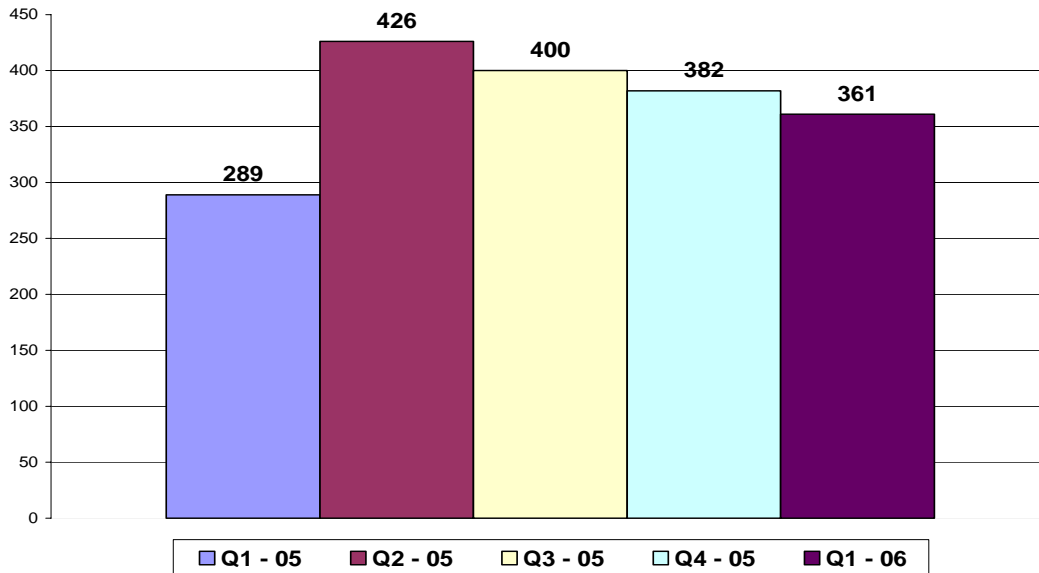
**City of Hamilton / ATH New Applicants

As of March 31, 2006**



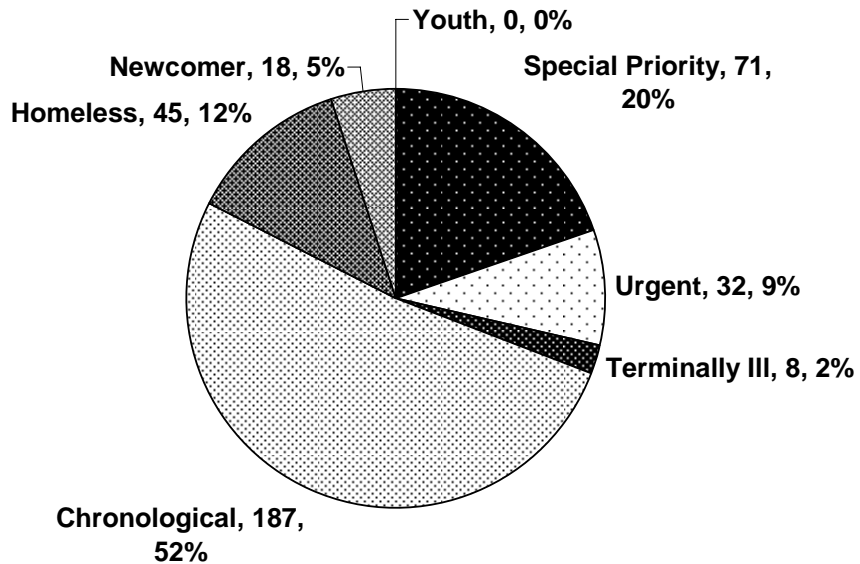
SUMMARY OF NEW APPLICANTS**City of Hamilton / ATH New Applicants

as of March 31, 2006**

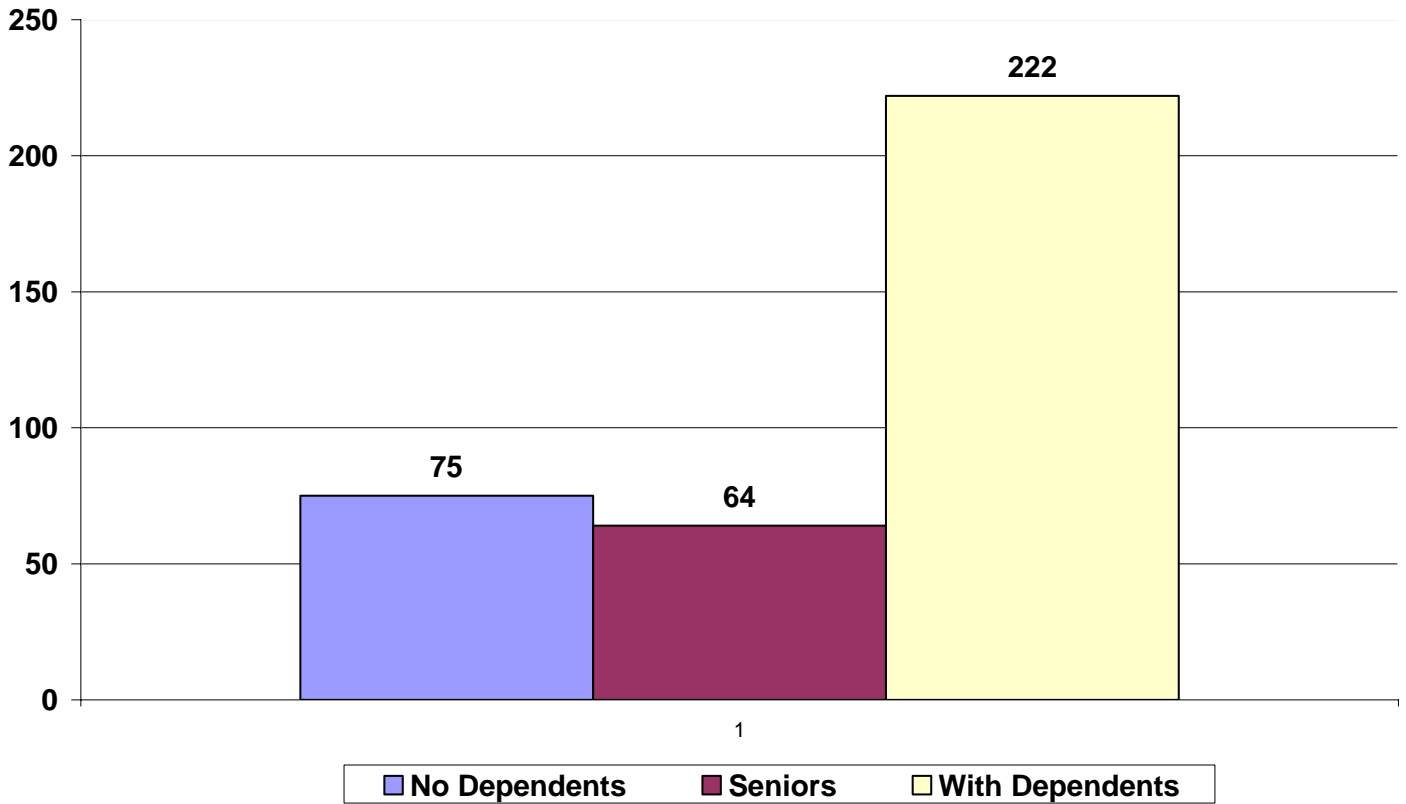
SUMMARY OF HOUSED APPLICANTS

Applicants Housed as at March 31, 2006**



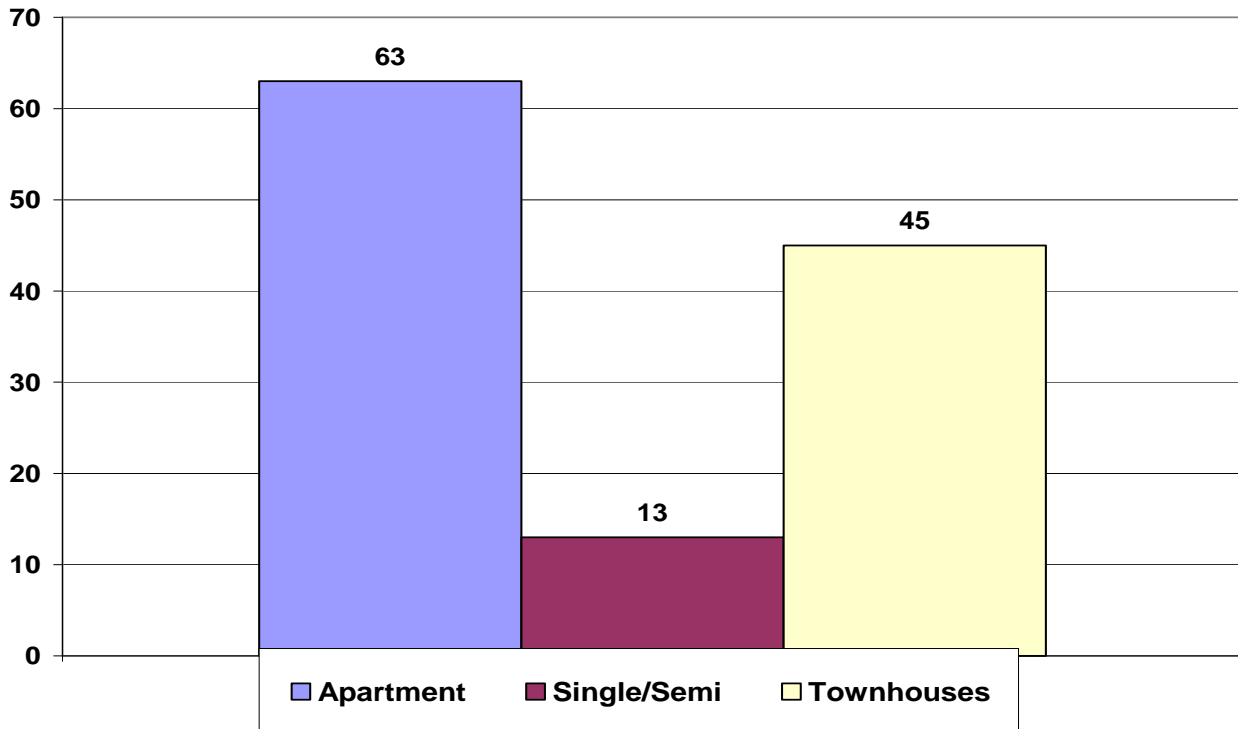
**City of Hamilton / ATH Housed Applicants

as at March 31, 2006**

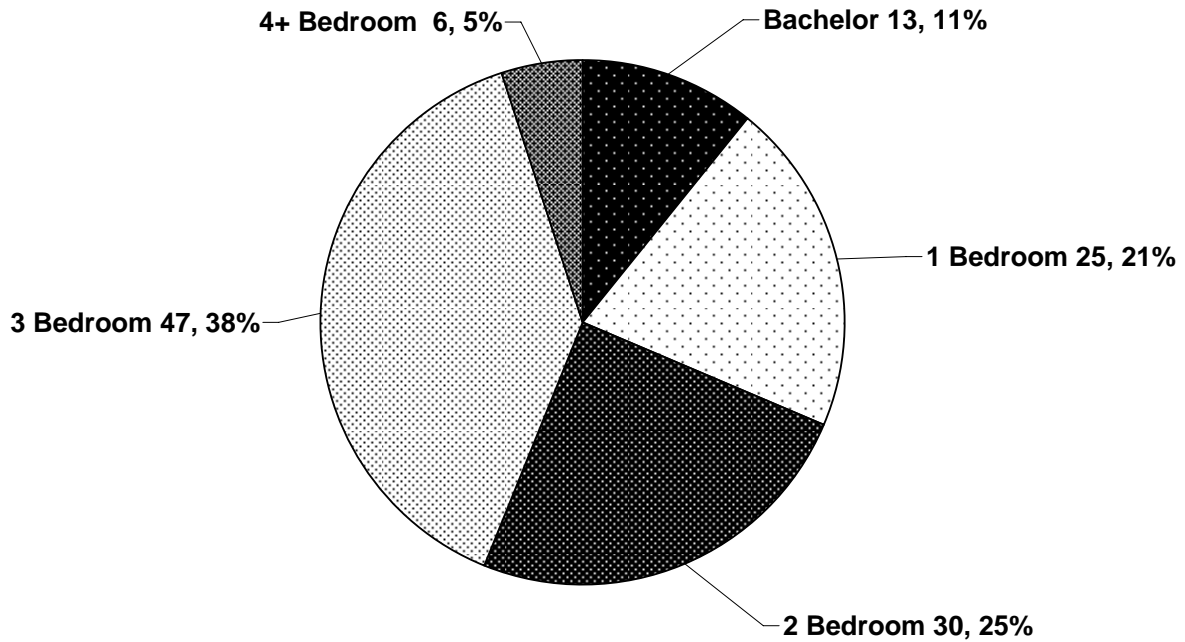


SUMMARY OF HOUSED APPLICANTS**City of Hamilton / ATH Applicants Housed
