- (c) That all barricading, detour signing and traffic control be subject to the direction and satisfaction of the General Manager of Public Works, or his designate;
- (d) That all barricading be supplied by and at the expense of the applicant;
- (e) That "Temporary Road Closure" signs be installed in advance by the Public Works Department, on the affected roadways, if deemed necessary by the General Manager of Public Works at the sole cost of the applicant;
- (f) That the applicant ensure that clean up operations be carried out immediately before the re-opening of the roads, to the satisfaction of the General Manager of Public Works at the expense of the event organizer;

- (a) That the application of the operator of “Gallagher’s Bar and Lounge”, located at 171 John Street South (69 Augusta Street), to erect and maintain an outdoor boulevard café within the Augusta Street road allowance, be approved, subject to the following conditions:
- (i) That the applicant and owner enter into an Outdoor Boulevard Café agreement in a form satisfactory to the General Manager, Public Works and the City Solicitor;
  - (ii) That the applicant pay the appropriate user fee and an annual fee based on 5% of the market value of the City land utilized at such time as the current moratorium end;

  - (v) That the applicant adhere to the City Council approved Technical Specifications for Outdoor Boulevard Cafes;
  - (vi) That the applicant adheres to the Urban Design Guidelines for Outdoor Boulevard Cafes on Public Property;
- (b) That the Boulevard Café Agreement be executed by the General Manager, Public Works or his designate, in accordance with the delegated authority granted by Section 3 of the 3<sup>rd</sup> Report of the 1999 Finance and Administration Committee, adopted by the former City of Hamilton Council on February 9, 1999.

**24. Approval for Alcohol as part of a Special Event (Baseball/Slo-Pitch Tournament – Fundraiser for Smith Family Trust Fund) – Turner Park - (ECS08037) (Ward 7) (Item 7.11)**

- (a) That Montana's Cookhouse – Ancaster be approved to host a Beer Garden at Turner Park, as part of a Fundraising Slo-Pitch Tournament with proceeds going to the Smith Family Trust Fund on Sunday, September 14, 2008, 11:00 a.m. and 6:00 p.m.
- (b) That, if the request to host a Beer Garden is approved, the hosting organizations must comply with:
  - (i) The Ontario Liquor License Act, R.S.O. 1990, Chapter L.19 and the administration of the Act by the Alcohol and Gaming Commission of Ontario (AGCO).
  - (ii) The conditions contained within the City of Hamilton's Municipal Alcohol Guidelines, Appendix A of the Policy for Special Event Planning.
  - (iii) The applicant must provide \$5,000,000 comprehensive general liability insurance coverage (which shall include a host liquor liability endorsement), and that the City of Hamilton is named as an additional insured party to this Policy.
  - (iv) The applicant must pay all City Service costs associated with the operation of this event.

**25. 2008 Heat Response Plan ECS08027(b) (Item 7.12)**

That the City's Heat Response plan be implemented on the second day of a 40 degree Celsius humidex heat event (Heat Warning stage), (the first day of a 40 degree Celsius humidex heat event is a Heat Advisory), for the remainder of the 2008 heat season as a pilot, to assess the usage and operating impacts of opening municipally-operated cooling centres as well as extended operating hours for outdoor City pools during prolonged heat events.

## Updated Forecasts:

- Updated projection of non-program revenue - \$500,000
- Updated projection of debt charge savings - \$1.0 million
- LCBO Interim Blue Box Funding – estimated additional \$100,000
- New funding announcement for Household Hazardous Waste Program - \$50,000

## Non-Service:

- Transfer of \$1.2 million in base budget from the corporate contingency to Recreation Services (\$1.1 million) and Customer Contact Centre (\$56,000) to offset the impact of CUPE 5167 contractual changes. The contingency is available from a provision made for 5167 job evaluation (JE) impacts. The 5167 JE has been implemented and the cost was less than the contingency.
- Transfer of \$0.4 million in base budget from corporate contingency to program areas impacted by the new statutory provincial holiday (“Family Day”).
- Limitations on discretionary spending.
- Delayed hiring to increase gapping in non-essential positions.

## Use of Reserves:

(only implemented if the deficit remains at year-end)

- Gas Tax funding to partially offset Transit shortfall - \$800,000.
- Winter Control reserve - \$1,800,000.
- Reduce transfer to Fleet reserve by \$145,000.

## Service Impacts:

- None recommended at this time.

  - (ii) the assumption by the Purchaser of all obligations of Clocktower under those agreements;

  - (v) the receipt of confirmation satisfactory to the City Solicitor that the Hotel will continue to be operated as a Sheraton;
