CITY OF HAMILTON

BY-LAW NO. 14-189

**To Amend the Waterworks By-law No. R84-026 and the
Water Wastewater/Storm Fees and Charges By-law No. 13-325**

WHEREAS on the 25th day of June, 2014, the Council of the City of Hamilton did approve of Item 7 of General Issues Committee Report 14-013 and did authorize the removal of certain water and wastewater/storm fees and charges set out herein from By-law Nos. R84-026 and 13-325 relating to Haldimand County and The Regional Municipality of Halton, as those water rates are to be negotiated and imposed through agreements entered into between the City of Hamilton and the appropriate municipalities;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule "G" of By-law No. R84-026 is amended by deleting the following paragraph and table under the heading "A) Daily Water Fixed Charge":

"For the supply of water to Haldimand County and The Regional Municipality of Halton, the daily water fixed charge is as follows:"


2. Schedule "G" of By-law No. R84-026 is further amended by deleting the following paragraph and table under the heading "B) Consumption Charge":

"For the supply of water to Haldimand County and the Regional Municipality of Halton, the metered water consumption charge is as follows:"



3. Schedule "A" to By-law No. 13-325 is amended by deleting under the heading "A) Daily Water & Wastewater/Storm Fixed Charges" the columns labelled "Haldimand Water Rate" and "Halton Water Rate" and the rates listed thereunder.
4. Schedule "A" to By-law No. 13-325 is further amended by deleting under the heading "B) Metered Water Consumption Charges" the columns labelled "Haldimand" and "Halton" and the rates listed thereunder.
5. This by-law comes into force on the day it is passed.
