BY-LAW No. 04-003

Respecting:

TARIFF OF FEES

WHEREAS the <u>City of Hamilton Act</u>, <u>1999</u>, Statutes of Ontario, 1999 Chap. 14, Sch. C did incorporate, as of January 1,2001, the municipality "City of Hamilton";

AND WHEREAS the City of Hamilton is the successor to:

- (a) the following former area municipalities: The Corporation of the Town of Ancaster; The Corporation of the Town of Dundas; The Corporation of the Town of Flamborough; The Corporation of the Township of Glanbrook; The Corporation of the City of Hamilton; and, The Corporation of the City of Stoney Creek, (hereinafter the said former area municipalities together may be referred to as the "former area municipalities" and a former municipality may be referred to as "(place name)"; and,
- (b) the former regional municipality, namely, The Regional Municipality of Hamilton-Wentworth;

AND WHEREAS the <u>City of Hamilton Act</u>, <u>1999</u> provides that the By-laws and resolutions of the former area municipalities continue in force in the City of Hamilton until subsequently amended or repealed by the Council of the City of Hamilton;

AND WHEREAS Section 69 of the <u>Planning Act</u>, R.S.O. 1990, Chapter 13, as amended, authorizes municipalities to enact a by-law to prescribe a Tariff of Fees for the processing of applications made in respect of planning matters;

AND WHEREAS the former area municipalities have enacted certain by-laws under section 69 of the <u>Planning Act</u> to establish a tariff of fees;

AND WHEREAS Section 3910f the <u>Municipal Act</u>, 2001, S.0.2001, c. 25, as amended, authorizes municipalities to enact by-laws to impose fees on any class of person for services or activities provided or done by or on behalf of the municipality;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

- 1. The Tariff of Planning Fees in Schedule "A" annexed hereto and forming part of this By-law are hereby approved and adopted.
- 2. The fees shall be paid at the time of and with the making of an application referred to in Schedule "A".
- 3. No application shall be deemed to have been made, and no application shall be received, unless the fee is paid in accordance with this by-law.
- 4. The amounts of the fees in Schedule "A" of this By-law shall be adjusted annually by the percentage change during the preceding year of the Consumer Price Index (CPI) for Toronto, and the resulting figures shall be rounded off to the nearest five (\$5.00) dollar interval.
- 5. The 2004 Development Engineering Fees in Schedule "B" annexed hereto and forming part of this By-law are hereby approved and adopted.
- 6. The amounts of the fees in Schedule "B" of this By-law shall be adjusted annually by the percentage change during the preceding year of the Consumer Price Index (CPI) for Toronto, and the resulting figures shall be rounded off to the nearest five (\$5.00) dollar interval.
- 7. No service or activity listed in Schedule "B" shall be provided or completed until the appropriate fee has been paid in accordance with this By-law.
- 8. The provisions of this By-law shall supersede the provisions of any by-law of any of the former municipalities with respect to the approval and imposition of a fee for the processing and review of any planning application, or related engineering service, in that former municipality.
- 9. This By-law shall be deemed to have come into force on January 1,2004.
