BY-LAW NO. 04-087

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS Section 314(7) of the <u>Municipal Act</u> confers upon councils of all municipalities the power to enact by-laws to provide for placing, regulating and maintaining upon the public highways traffic signs for the purpose of guiding and directing traffic;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by adding to Subsection 1(B) of Section "E" thereof (3 hours at \$1.00 per hour) the following item, namely:

"Hunter South Catharine to Walnut"

and by deleting from Subsection 2(b) of Section "E" thereof (2 hours at \$1.00 per hour) the following item, namely:

"Hunter South Catharine to Walnut"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Grays West Q.E.W. to northerly end Anytime

Grays East 336 feet north of Frances to the northerly Anytime"

end

and by adding to Section "E" thereof the following items, namely:

"Grays West Q.E.W. to Lakepoint Anytime

Grays East from 102.5m north of Frances to Lakegate Anytime"

3. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Eaglewood East Royal Vista to 23.5m southerly Anytime

Grays West Lakepoint to northerly end of Grays Anytime

Grays East Lakegate to northerly end of Grays Anytime"

- **4.** Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 5. This By-law shall come into force and take effect on the date of its passing and enactment.
