BY-LAW NO. 04-099

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating traffic on highways subject to the Highway Traffic Act;

AND WHEREAS Section 314(7) of the Municipal Act confers upon councils of all municipalities the power to enact by-laws to provide for placing, regulating and maintaining upon the public highways traffic signs for the purpose of guiding and directing traffic:

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Augusta	North	commencing 69 feet west of Hughson and extending 26 feet westerly therefrom	Anytime
Oak	West	from 86.9m south of Barton to 7.3m southerly	Anytime
Primrose	North	commencing 44 feet west of Avondale and extending 17 feet westerly therefrom	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Ray East from 156.7m south of Barton to 6.1m Anytime" southerly

2. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Emerald	East	22 feet	177 feet north of Robert		Anytime
Ferndale	East	28 feet	121 feet south of Dun	kirk	Anytime
Ferndale	East	28 feet	140 feet south of Dun	kirk	Anytime
Westlawn	South	22 feet	240 feet west of the extended west curb line of Katie Court	7:00 a.m	n. – 5:00 p.m."

and by adding to Section "E" thereof the following item, namely:

"Dartford West from 69.5m south of Camelot to 8:00 a.m. to 5:00 p.m." 9.5m southerly

- 3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 4. This By-law shall come into force and take effect on the date of its passing and enactment.
