

**Bill No. 153**

**CITY OF HAMILTON**

**BY-LAW NO. 04-153**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** Section 314(7) of the Municipal Act confers upon councils of all municipalities the power to enact by-laws to provide for placing, regulating and maintaining upon the public highways traffic signs for the purpose of guiding and directing traffic;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Section 9 of By-law 01-215, as amended, is hereby further amended by deleting Subsection (2)(c) therefrom, in its entirety, and inserting in its place the following Subsection, namely:

“(c) in column 3 thereof, the municipal name of the intersecting highway.”

2. Section 10 of By-law 01-215, as amended, is hereby further amended by deleting Subsection (2)(c) therefrom, in its entirety, and inserting in its place the following Subsection, namely:

“(c) in column 3 thereof, the municipal name of the intersecting highway.”

3. Schedule 4 (Yield Signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section “A” thereof, the following items, namely:


