BY-LAW NO. 04-302

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Brucedale North from 32.9m east of East 30 min 1 pm – 8 pm Anyday" 13th to 5.5m easterly

and by adding to Section "E" thereof the following item, namely:

"Gateview Both West 5th to Arcade 3 hr Anytime Anyday"

and by deleting from Subsection $^{\shortparallel}A$ 'of Section $^{\shortparallel}G$ " thereof the following item, namely:

"Gage East side from a point 104 feet 1 hour 9:00 a.m. to 2:00 a.m." south of Beechwood to a point 96 feet southerly therefrom

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"East 35th East Concession to 33.8m southerly Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Pearl East commencing at a point 90 feet south of Peter Anytime"

to a point 31 feet southerly therefrom

and by adding to Section "E" thereof the following items, namely:

"Balsam East from 32.3m north of Afton to 6.7m northerly Anytime

Balsam West from 23.8m north of Afton to 4.6m northerly Anytime

Cumberland South from 14.8m east of Eastbourne to Anytime

7.5m easterly

Smith West from 163.4m north of Cannon to 4m Anytime

northerly

Smith West from 167.4m north of Cannon to 6.4m Anytime

northerly

Walter West from 47.8m south of Barton to 6.1m Anytime"

southerly

and by deleting from Section "F" thereof the following item, namely:

"Wardrope East from 64.5m south of King Street West to Anytime"

Avenue 6.7m southerly

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Hixon South Mount Albion to 11.9m easterly Anytime

Sanford West from 5.2m south of the extended 7:00 a.m. to 6:00 p.m."

curb line of Huron to 96.6m Monday to Friday

southerly

and by adding to Section "E" thereof the following items, namely:

"Hixon South Mount Albion to 31.4m easterly Anytime

Sanford West from 5.2m south of the extended 7:00 a.m. to 6:00 p.m."

south curb line of Huron to 96.6m Monday to Friday

southerly

5. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"East 37th East 80 feet 232 feet north of the north 7:00 a.m. - 6:00 p.m."

curb line of Seventh

Monday to Saturday

and by adding to Section "E" thereof the following item, namely:

"East 37th East from 87.3m south of Fennell 7:00 a.m. to 6:00 p.m."

to 82.7m southerly

Monday to Saturday

- 6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 7. This By-law shall come into force and take effect on the date of its passing and enactment.
