CITY OF HAMILTON

BY-LAW NO. 04-321

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by adding to Subsection 3(a) of Section "E" thereof (1 hour @ 50¢ per hour) the following item, namely:

"Main North Walnut to Spring"

and by deleting from Subsection 4(a) of Section "E" thereof (1/2 hour @ 50¢ per hour) the following item, namely:

"Main North Walnut to Spring"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "F" thereof the following item, namely:

"Crompton Both Lincoln Road to the easterly end of Anytime"
Way Crompton Way

and by adding to Section "F" thereof the following item, namely:

"Crompton South Lincoln Road to Norwich Road Anytime"
Way

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Avondale East commencing 124 feet north of Primrose and Anytime
extending 18 feet northerly therefrom

Avondale West commencing 139 feet north of Primrose and Anytime
extending 18 feet northerly therefrom

Cambridge South commencing 78 feet east of Robins and Anytime"
extending 20 feet easterly therefrom

and by adding to Section "E" thereof the following items, namely:

"Fairfield East from 33.7m north of Britannia to 5.8m Anytime
northerly

Ferguson East from 38.7m north of Ferrie to 6.7m northerly Anytime

Garfield West from 57.6m north of King to 6.3m northerly Anytime

Rosslyn East from 68m north of Campbell to 5.8m Anytime
northerly

Rosslyn West from 70.1m north of Campbell to 5.5m Anytime
northerly

Sherman East from 117.4m north of Cumberland to 7.3m Anytime"
northerly

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Hess West from 40.2m north of Cannon to 8:00 a.m. to 4:00 p.m."
26.2m northerly Monday to Friday

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Franklin East 33 feet commencing 57 feet east 3:00 p.m. – 4:00 p.m."
of East 27th Monday to Friday

6. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Hess West from 18.9m north of Cannon to 8:00 a.m. to 4:00 p.m."
21.3m northerly Monday to Friday


7. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Munroe North 50 feet commencing 184 feet east 7:00 a.m. – 6:00 p.m."
of Wentworth Monday to Saturday

Wentworth East from 4.3m south of Mars to 7:00 a.m. to 6:00 p.m."
15.2m southerly Monday to Saturday

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
9. This By-law shall come into force and take effect on the date of its passing and enactment.
