CITY OF HAMILTON

BY-LAW NO. 05-315

**To Amend Bylaw No. 01-218, as amended,
Being a Bylaw To Regulate On-Street Parking**

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following items, namely:

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

5. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "F" thereof the following item, namely:

6. Schedule 16 (Taxi Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Barton North from 43.1m east of Gibson to 13.6m easterly Anytime"

7. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "F" thereof the following item, namely:

"First Street East From a point 94m south of King St. W. 8:00 am – 9:00 am"
South to a point 152m south of King St. W. 11:30 am – 1:00 pm
3:15 pm – 4:15 pm

and by adding to Section "E" thereof the following item, namely:


"First East from 98.9m south of King to 59m 7:00 a.m. to 6:00 p.m."
southerly Monday to Friday

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

9. This By-law shall come into force and take effect on the date of its passing and enactment.
