BY-LAW NO. 06-150

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Rowanwood Both Beach to the 1 hr 8 am – 8 am Mon - Sun" southerly end (24 hrs)

and by adding to Section "E" thereof the following item, namely:

"Brucedale Both East 31st to East 32nd 1 hr 8 am – 5 pm Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "B" thereof the following item, namely:

"Hatt St. North John St. to 71.3m westerly Anytime"

and by adding to Section "B" thereof the following item, namely:

"Hatt North John to 56.1m westerly Anytime"

and by adding to Section "C" thereof the following item, namely:

"Slater East & From 88.5m south of Kildonan

North to 19.8m southerly and

easterly along the inside bend

and by deleting from Section "E" thereof the following item, namely:

"Mary East Picton to 66 ft. north Anytime"

and by adding to Section "E" thereof the following item, namely:

"Bendamere Both Upper Paradise to West 31st 8:00 a.m. to 5:00 p.m."

Monday to Friday

Anytime"

and by adding to Section "G" thereof the following item, namely:

"Beach Rd. North From 8.2m west of Anytime"

Rowanwood to 7.2m westerly

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Clinton North commencing at a point 161 feet east Anytime

of Barnesdale to a point 22 feet

easterly therefrom

Cumberland North From 31.4m east of Norway to 6.4m Anytime

easterly

Hughson West from 31.8m south of Ferrie to 6.1m Anytime

southerly

London East From 19.8m south of Cannon to 5.8m Anytime

southerly

Ray	East	commencing 212 feet north of York and extending 17 feet northerly therefrom	Anytime
Roosevelt	East	From 45.2m south of Beach to 6m southerly	Anytime
Wood	South	From 109.1m east of Mary to 6.7m easterly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

"Slater East Kildonan to 22.5m southerly Anytime"

and by deleting from Section "E" thereof the following item, namely:

"Wentworth West Burlington to Charlton 4:00 p.m. to 6:00 p.m."

Monday to Friday

and by adding to Section "E" thereof the following item, namely:

"Wentworth West Barton to Charlton 4:00 p.m. to 6:00 p.m."

Monday to Friday

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Balsam West From 19m south of Maplewood 8:00 a.m. to 6:00 p.m." to 6m southerly

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
