CITY OF HAMILTON

BY-LAW NO. 06-172

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Dalewood	East	Sterling to Paisley	1 hr	8 am – 6 pm	Mon – Fri
Dalewood	West	From 200 ft. north of Sterling to Paisley	1 hr	8 am – 6 pm	Mon – Fri
Dalewood	Both	Paisley to Oak Knoll	1 hr	8 am – 6 pm	Mon – Fri"

and by adding to Section "E" thereof the following items, namely:

"Dalewood	Both	Sterling to Paisley	1 hr	8 am – 9 pm	Mon – Fri
Dalewood	Both	Paisley to the northern intersection with Oak Knoll	1 hr	8 am – 6 pm	Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Bourbon	East	Brigade to south end	Anytime
Dalewood Cr.	West	Sterling to 200 ft. north	Anytime
East 27 th	East	Concession to 133 ft. south	Anytime
Kenilworth	West	from 9.6m south of Hope to 6.8m southerly	Anytime
Mary	West	Picton to 100 ft. north	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Acadia	North & East	From 67m east of Mapleridge to 65m easterly and southerly along the outside bend	Anytime
Dalewood	West	Sterling to 61m northerly	Anytime
East 27 th	East	Concession to 21.1m southerly	Anytime
Kenilworth	West	From 9.6m south of Hope to 13.7m southerly	Anytime
Mary	East	Picton to 66 ft. north	Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Belmont	East	From 79.7m north of Campbell to 7m northerly	Anytime
Brock	South	commencing 89 feet east of John and extending 24 feet easterly therefrom	Anytime
Fairfield	East	213 feet south of Vansitmart to 22 feet southerly	Anytime
Niagara	East	commencing 153 feet north of Munroe and extending 20 feet northerly therefrom	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Dalewood East Sterling to 96 feet north Anytime"

and by adding to Section "E" thereof the following item, namely:

"Dalewood East Sterling to 29.3m northerly Anytime"

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Barnesdale East from 18.2m north of Rosemont 7:00 a.m. to 5:00 p.m." to 6.7m northerly


and by adding to Section "E" thereof the following items, namely:

"Barnesdale East From 18.2m north of Rosemont to 6.7m northerly Anytime

Brock South From 27.1m east of John to 7.3m easterly Anytime"

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
