BY-LAW NO. 06-279

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

- 1. By-law No. 01-218, as amended, is hereby further amended by deleting paragraph (a), in its entirety, from subsection 12(6) thereof and substituting in its place the following paragraph, namely:
 - "(a) No person shall park any vehicle on any highway or part highway listed in Schedule 2 as set out in Section 10(7), between the hours of 2:00 a.m. and 7:00 a.m. provided that this shall not serve to prohibit the standing of a taxi cab, that is occupied by the operator, in a designated taxi zone listed in Schedules 16 or 17 of this by-law, while said taxi zone is in force and effect."
- 2. By-law No. 01-218, as amended, is hereby further amended by deleting paragraph (a), in its entirety, from subsection 12(8) thereof and substituting in its place the following paragraph, namely:
 - "(a) No person shall park any vehicle upon any of the highways or part highways listed in Schedule 8 of this By-law, provided suitable signs are erected and maintained and provided that this shall not serve to prohibit the standing of a taxi cab, that is occupied by the operator, in a designated taxi zone listed in Schedule 16 or 17 of this by-law, while said taxi zone is in force and effect."

6. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:
