CITY OF HAMILTON

BY-LAW NO. 06-299

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. By-law No. 01-218, as amended, is hereby further amended by deleting the term "4 tonnes" from Sections 10(1)(a) and Sections 11(1)(a) thereof and substituting in its place the term "4,500 kilograms.
2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "A" thereof the following items, namely:

"Old Mohawk Rd.	North	From 139.6m west of Mohawk Rd. to the westerly end	Anytime
Old Mohawk Rd.	South	Mohawk Rd. to 174m westerly	Anytime
Old Mohawk Rd.	South	From 388m west of Mohawk Rd. to the westerly end	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Old Mohawk	South	Mohawk to 74.8m westerly	Anytime
-------------	-------	--------------------------	---------

Old Mohawk	South	From 388m west of Mohawk to 176.6m westerly	Anytime"

and by adding to Section "C" thereof the following item, namely:

"Main	West	From 60.9m south of the extended south curb line of Buchan to 29.7m southerly	Anytime"

and by deleting from Section "E" thereof the following item, namely:

"Waverly	West	commencing 62 feet north of Melvin and extending 85 feet northerly therefrom	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Waverly	West	Melvin to 46.1m northerly	Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"John	East	from 22.6m south of Picton to 5m southerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Cope	East	From 23m south of Barton to 5.8m southerly	Anytime
-------	------	---	---------

Garfield	West	From 12.8m south of the north end of Garfield to 7.6m southerly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Edgemont	East	From 88.7m south of Dunsmure to 4.8m southerly	Anytime"

5. Schedule 16 (Taxi Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Queen West King to George 6:00 p.m. to 3:00 a.m."


and by adding to Section "E" thereof the following item, namely:

"Queen East King to George 6:00 p.m. to 3:00 a.m."

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
