

The following text together with Schedule "B" – Special Policy Areas, attached hereto, constitutes Official Plan Amendment No. 209.

Purpose:

The purpose of this Amendment is to allow for the construction of the North Hamilton Community Health Centre on the lands formally occupied by Bennetto Elementary School.

Location:

The lands affected by this Amendment are known municipally as 444 Hughson Street North within the North End East Neighbourhood.

Basis:

The basis for permitting the proposed the medical clinic is as follows:

- (i) It is consistent with the Provincial Policy Statement, and it conforms to the policies of the Hamilton-Wentworth Official Plan;
- (ii) It will allow development compatible with existing and planned uses in the surrounding neighbourhood; and,
- (iii) It is an appropriate infill use that will make use of existing services in a mature neighbourhood.

Actual Changes:

- Schedule "B" Special Policy Areas be revised by identifying the subject lands as Special Policy Area 93, as shown on the attached Schedule "A" of this Amendment.
- 2) The following new policy be added to Subsection A.2.9.3. Other Policy

Areas as Policy A.2.9.3.86:

"In addition to the permitted uses set out in Subsection A.2.6 – Major Institutional Uses, for those lands known municipally as 444 Hughson Street North and shown on Schedule "B" as SPECIAL POLICY AREA 93, a medical clinic will be permitted."


Implementation:

A Zoning By-law amendment and site plan will give effect to the intended use on the subject lands.


