BY-LAW NO. 07-354

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Adams West Cannon to southerly 2 hr 8am – 8pm Anyday" end of Adams

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Harrisford West Greenhill to 157 feet northerly 9 am – 5 pm" therefrom Mon - Fri

and by adding to Section "E" thereof the following items, namely:

"Harrisford West Greenhill to 49.4m northerly Anytime

National	North	from 117.5m southerly and westerly along the curb line from the eastern intersection with Tommar to 8m westerly	Anytime
Whitney	South	from 97.5m east of Rifle Range to 150m easterly	7:00 a.m. to 6:00 p.m." Monday to Friday

and by deleting from Section "F" thereof the following item, namely:

"Sunvale South from southern intersection with Anytime" & West Waterford to 134.8m westerly

and by adding to Section "F" thereof the following item, namely:

"Sunvale South from southern intersection with Anytime" & West Waterford to 123.4m westerly and northerly

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Homewood	South	Locke to 26.5m easterly	Anytime
Locke	East	Aberdeen to Homewood	Anytime
Park Row	East	commencing 19.8m south of Cannon and extending 5.8m southerly therefrom	Anytime
Tisdale	East	commencing 142 feet south of Main and extending 17 feet southerly therefrom	Anytime
Tisdale	West	commencing 120 feet south of Main and extending 17 feet southerly therefrom	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Locke East from 22.9m south of Homewood to Anytime 5.8m southerly

Locke East from 10.6m south of Homewood to Anytime 4.6m southerly

Lottridge West from 20.8m south of Rosemont to 6m southerly

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Graham East 29 feet 81 feet north of 8:00 a.m. – 4:00 p.m."

- 5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 6. This By-law shall come into force and take effect on the date of its passing and enactment.
