## **CITY OF HAMILTON**

### **BY-LAW NO. 08-014**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Birge	South	Wellington to 48.1m west of Victoria	3 hr	50¢"

and by adding to Section "E" thereof the following item, namely:

2. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following item, namely:

"Londonderry	Both	Lowinger to east end of Londonderry	2 hr	8 am – 5 pm	Mon – Fri"

5. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

Claremont	South	Arcade to 48m westerly	Anytime”

and by adding to Section "E" thereof the following items, namely:

“Ambassador	Both	Elgar to Montcalm	Anytime
Birge	North	Victoria to 41.8m westerly	Anytime
Brige	South	Victoria to 15.5m westerly	Anytime
Claremont	South	Arcade to 35.2m westerly	Anytime”

6. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:


“East 8th	West	from 76.2m north of Brucedale to 4.4m northerly	8:00 a.m. to 5:00 p.m.” Monday to Friday
