**CITY OF HAMILTON**

**BY-LAW NO. 08-080**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Stop Signs) of By-law No. 01-215, as amended, is hereby further amended by deleting from Section "D" thereof the following items, namely:

"Edna Avenue	Southbound	Blue Mountain Drive
Bates Avenue	Southbound	Blue Mountain Drive
Tossell Avenue	Southbound	Blue Mountain Drive
Tossell Avenue	Northbound	Pinehill Drive

Bocelli Crescent	Southbound	Pinehill Drive

Valiant Circle	Westbound	Fall Fair Way"

and by deleting from Section "F" thereof the following item, namely:

"Falcon Road                      Eastbound                      Fifty Road"

2. Schedule 2 (Speed Limits) of By-law No. 215, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Dunsmure Rd.                      Tragina Ave. N.                      Weir S.N.                      40  
Bonaparte Way                      Brigade Dr.                      Brigade Dr."

and by adding to Section "E" thereof the following items, namely:

"Dunsmure Rd.                      Tragina Ave. N.                      Weir St.N.                      40  
Bonaparte Way                      Brigade Dr.                      Brigade Dr.                      40"

and by deleting from Section "C" thereof the following item, namely:


"Milborough Line                      11<sup>th</sup> Conc. East                      Campbellville Road 518                      70km/h"


and by adding to Section "C" thereof the following item, namely:
