## CITY OF HAMILTON

## BY-LAW NO. 08-081

## To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

**WHEREAS** Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "A" thereof the following item, namely:

"Church St. South Wilson St. E. to Lodor St.

Anytime"

and by adding to Section "A" thereof the following item, namely:

"Church

Both

Wilson to Lodor

Anytime"

and by deleting from Section "E" thereof the following item, namely:

"Fairleigh

East

King to Wilson

Anytime"

and by adding to Section "E" thereof the following items, namely:

"Caledon

East

Aldridge to Jameston

8:00 a.m. to 6:00 p.m. December 1<sup>st</sup> to March 31<sup>st</sup> Fairleigh East King to Wilson December 1<sup>st</sup> to March 31<sup>st</sup>

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Thorpe West from 13.7m south of King to 6m Anytime" southerly

and by deleting from Section "E" thereof the following item, namely:

"Maplewood North from 80.5m east of Balsam to 6.4m Anytime" easterly

and by adding to Section "E" thereof the following items, namely:

"Grosvenor East from 19.2m south of Campbell to 6m Anytime

southerly

Grosvenor West from 12.6m south of Campbell to 6m Anytime"

southerly

3. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "F" thereof the following item, namely:

"Green West Carla to 39.3m northerly Anytime"

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Hunt North from 30.6m east of 8:00 a.m. to 4:00 p.m."

Breadalbane to 6.1m easterly Monday to Friday

and by adding to Section "E" thereof the following item, namely:

"Maplewood North from 80.5m east of Balsam to Anytime" 6.4m easterly

- 5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 6. This By-law shall come into force and take effect on the date of its passing and enactment.
