BY-LAW NO. 08-100

To Amend By-law No. 01-215 Being a By-law To Regulate Traffic

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"York Blvd. North Limit of the South side of High Level 70"
City boundary Bridge

City boundary Bridge

and by deleting from Section "G" (Former Regional Roads) Section 1 (Hamilton) the following items, namely:

"York Blvd. 1700 ft. north of North City Limits 70

Woodbine Crescent

York Blvd. North Limit of the North Limit of the Regional 70"

City of Hamilton Municipality of Hamilton-

Wentworth

2. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"York Blvd. south side of High 2nd Lane from Anytime Northerly Level Bridge to East Curb to Hwy. 403 on-ramp Easterly"

3. Schedule 18 (Bike Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"York Blvd. North Limit of East curb Anytime Northbound the City lane Boundary to Woodbine Cres York Blvd. North Limit of West curb Anytime Southbound" the City lane Boundary to Woodbine Cres

4. Schedule 19 (Bike Paths) of By-law No. 01-215, as amended, is hereby further amended by deleting from Section "E" (Hamilton) the following item, namely:

"York Boulevard North Old Hamilton North City Limits to Harvey Park"

5. Schedule 20 (Combined Foot & Bicycle Paths) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"York Blvd. East side Valley Inn Road to 110m north of Old Guelph Road

York Blvd. East side 20m north of Old Guelph Road to north end of Hwy 403 on-ramp bridge

York Blvd. East side South end of High Level Bridge

to Rolph's Gate"

- 6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 7. This By-law shall come into force and take effect on the date of its passing and enactment.
