CITY OF HAMILTON

BY-LAW NO. 08-165

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Adams	West	Cannon to southerly end of Adams	2 hr	8 am – 8 pm	Anyday"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

Stuart	North	From 272 ft. west of Bay to 100 ft. westerly		Anytime"

and by adding to Section "E" thereof the following items, namely:

"Stuart	South	Bay to 14.7m west of Tiffany	Anytime
Upper Paradise	West	Scenic to northerly end	Anytime"

and by adding to Section "F" thereof the following item, namely:

"Margaret	Both	Barton to Arvin	9:00 a.m. to 4:00 p.m." Monday to Friday

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Cope	West	from 13.4m south of Dunsmure to 4.2m southerly	Anytime
Cope	East	from 10.3m south of Dunsmure to 5.5m southerly	Anytime
Douglas	East	from 29.1m north of Francis to 5.5m northerly	Anytime
Douglas	West	from 30.4m south of Mars to 5.5m southerly	Anytime
Fullerton	East	from 64.6m south of Princess to 7.1m southerly	Anytime
Lincoln	East	from 22.2m north of Barton to 5.6m northerly	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Gordon	South	from 67.4m east of Cavell to 5.5m easterly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Stuart North Queen to Hess Anytime"

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Folkestone West From 67.9m south of Berko to 7m southerly 8:00 a.m. to 6:00 p.m." Monday to Friday

"Glennie East from 32.8m south of Melvin to 7.8m southerly 8:00 a.m. to 10:00 a.m., 2:00 p.m. to 4:00 p.m." Monday to Friday

and by adding to Section "E" thereof the following item, namely:

"Glennie East from 32.8m south of Melvin to 7.8m southerly Anytime"


6. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Hughson East 30 feet 50 feet north of King William 8:00 A.M. to 6:00 P.M." Mon to Fri

7. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

8. This By-law shall come into force and take effect on the date of its passing and enactment.
