# CITY OF HAMILTON

**BY-LAW NO. 08-193** 

To Amend Zoning By-law No. 464 (Glanbrook)
Respecting Lands located at Part of Lot 5, Concession 3,
Township of Glanford (Glanbrook)

**WHEREAS** the <u>City of Hamilton Act. 1999</u>, Statutes of Ontario, 1999 Chap.14, Sch. C. did incorporate, as of January 1<sup>st</sup>, 2001, the municipality "City of Hamilton";

**AND WHEREAS** the City of Hamilton is the successor to certain area municipalities, including the former area municipality known as "The Corporation of the Township of Glanbrook" and is the successor to the former Regional Municipality, namely, The Regional Municipality of Hamilton-Wentworth;

**AND WHEREAS** the <u>City of Hamilton Act, 1999</u> provides that the Zoning By-laws of the former area municipalities continue in force in the City of Hamilton until subsequently amended or repealed by the Council of the City of Hamilton;

**AND WHEREAS** Zoning By-law No. 464 (Glanbrook) was enacted on the 16<sup>th</sup> day of March, 1992, and approved by the Ontario Municipal Board on the 31<sup>st</sup> day of May, 1993;

**AND WHEREAS** the Council of the City of Hamilton, in adopting Item 17 of Report 08-015 of the Planning and Economic Development Committee at its meeting held on the 7<sup>th</sup> day of August, 2008, recommended that Zoning By-law No. 464 (Glanbrook), be amended as hereinafter provided;

**AND WHEREAS** this by-law is in conformity with the Official Plan of the City of Hamilton (the Official Plan of the former Township of Glanbrook);

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. That Schedule "A", appended to and forming part of By-law No. 464 (Glanbrook) is amended,

a) by changing the zoning on **Block 2** from the Airport "AT" Zone to the Airport-Related General Industrial "M4" Zone:

the extent and boundaries of which are shown on a plan hereto annexed as Schedule "A".

- 2. That no building or structure shall be erected, altered, extended or enlarged, nor shall any building or structure or part thereof be used, nor shall any land be used, except in accordance with the Airport-Related General Industrial "M4" Zone.
- 3. That the Clerk is hereby authorized and directed to proceed with the giving of notice of the passing of this By-law, in accordance with the <u>Planning Act</u>.


