BY-LAW NO. 08-209

Respecting:

Removal of Part Lot Control
Lots 22-30, Registered Plan No. 62M-1098, "Rose Garden – Phase 3"

WHEREAS the sub-section 50(5) of the *Planning Act*, (R.S.O. 1990, Chapter P.13, as amended, establishes part-lot control on land within registered plans of subdivision;

AND WHEREAS sub-section 50(7) of the *Planning Act*, provides as follows:

"(7) **Designation of lands not subject to part lot control.** -- Despite subsection (5), the council of a local municipality may by by-law provide that subsection (5) does not apply to land that is within such registered plan or plans of subdivision or parts of them as are designated in the by-law."

AND WHEREAS the Council of the City of Hamilton is desirous of enacting such a by-law with respect to the lands hereinafter described;


NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Sub-section 5 of Section 50 of the *Planning Act*, for the purpose of creating nine (9) parts for maintenance easements described as Parts 1-9, on Reference Plan 62R-18069, shall not apply to lands within the portion of the registered plan of subdivision that is designated as follows:

Lots 22-30, Registered Plan No. 62M-1098, in the City of Hamilton

2. This by-law shall be registered on title to the said designated land and shall come into force and effect on the date of such registration.
3. This by-law shall expire and cease to be of any force or effect on the 10th day of September, 2010.
