CITY OF HAMILTON

BY-LAW NO. 08-222

To Amend Zoning By-law No. 464 Respecting Lands Located at 9075-9089 Airport Road (Mount Hope)

WHEREAS the <u>City of Hamilton Act, 1999</u>, Statutes of Ontario, 1999 Chap. 14, Sch. C. did incorporate, as of January 1, 2001, the municipality "City of Hamilton";

AND WHEREAS the City of Hamilton is the successor to certain area municipalities, including the former municipality known as the "The Corporation of the Township of Glanbrook" and is the successor to the former regional municipality, namely, "The Regional Municipality of Hamilton-Wentworth";

AND WHEREAS the <u>City of Hamilton Act, 1999</u>, provides that the Zoning By-laws and Official Plans of the former area municipalities and the Official Plan of the former regional municipality continue in force in the City of Hamilton until subsequently amended or repealed by the Council of the City of Hamilton;

AND WHEREAS Zoning By-law No. 464 (Glanbrook) was enacted on the 16th day of March, 1992, and approved by the Ontario Municipal Board on the 31st day of May, 1993;

AND WHEREAS the Council of the City of Hamilton, in adopting Section 31 of Report 06-005 of the Planning and Economic Development Committee at its meeting held on the 12th day of April, 2006, recommended that the Director of Development and Real Estate be authorized to give notice and prepare by-laws for presentation to Council, to remove the "H" Holding provision from By-laws where the conditions have been met;

AND WHEREAS this by-law is in conformity with the Township of Glanbrook Official Plan, approved by the Minister under the <u>Planning Act</u> on June 16, 1987.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. That Sheet No. F, appended to and forming part Township of Glanbrook Zoning Bylaw No. 464, is further amended by changing from the "H-C3-043' (General Commercial - Holding) District Modified to the "C3" (General Commercial) District on the lands, the extent and boundaries of which are shown on a plan hereto annexed as Schedule "A".

- 2. No building or structure shall be erected, altered, extended or enlarged, nor shall any building or structure or part thereof be used, nor shall any land be used, except in accordance with the "C3" (General Commercial) District provisions.
- 3. Township of Glanbrook Zoning By-law No. 464 is amended by deleting Subsection "H-C3-043" from Section 44: EXCEPTIONS TO THE PROVISIONS OF THIS BY-LAW.
- 4. The Clerk is hereby authorized and directed to proceed with the giving of notice of the passing of this by-law, in accordance with the <u>Planning Act</u>.


