**CITY OF HAMILTON**

**BY-LAW NO. 09-034**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Stop Signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "A" (Ancaster) thereof the following items, namely:

"Tradewind Dr.	Southbound	Cormorant Dr.
Regan Dr.	Westbound	Springbrook Ave.
Regan Dr.	Eastbound	Oleary Dr.
Chambers Dr.	Northbound/Southbound	Regan Dr.
Chambers Dr.	Southbound	Lockman Dr.
Lockman Dr.	Westbound	Springbrook Ave.
Lockman Dr.	Eastbound	Fair St.
Oleary Dr.	Southbound	Fair St.

Valridge Dr.	Northbound	Valridge Dr.
Speers Rd.	Westbound	Valridge Dr"

and by adding to Section "B" (Dundas) thereof the following item, namely:

"Morrow St.                      Eastbound and Westbound                      Best Ave."

and by deleting from Section "E" (Hamilton) thereof the following items, namely:

"Kimberly	Northbound	Kenilworth
Hillyard St.	Southbound	Land St"

and by adding to Section "E" (Hamilton) thereof the following items, namely:


"Hillcrest Ave.	Eastbound & Westbound	Mountain Ave.
Hillyard St.	Northbound & Southbound	Land St"

2. Schedule 4 (Yield Sign) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following item, namely:

"Kimberly                      Northbound                      Kenilworth"

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
4. This By-law shall come into force and take effect on the date of its passing and enactment.
