BY-LAW NO. 09-112

A BY-LAW TO AUTHORIZE THE SUBMISSION OF APPLICATIONS TO THE RECREATIONAL INFRASTRUCTURE PROGRAM IN ONTARIO FOR FUNDING FROM THE RECREATIONAL INFRASTRUCTURE CANADA PROGRAM IN ONTARIO AND ONTARIO RECREATION PROGRAM AS ELIGIBLE CAPITAL PROJECTS OF THE CITY OF HAMILTON,

WHEREAS the *Municipal Act, 2001* (Ontario), as amended, (the "Act") provides that a municipal power shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

AND WHEREAS the Government of Canada has recently announced an investment of \$500 Million dollars nationally under the Recreational Infrastructure Program;

AND WHEREAS it is now deemed to be expedient to authorize for the municipal purposes of the Municipality the capital projects described in Schedule "A" (the "**Project**") attached hereto and forming part of this By-law ("**Schedule "A"**") in the amount of the estimated expenditures set out in Schedule "A";

AND WHEREAS the Federal and Provincial governments have invited eligible Ontario municipalities desirous of obtaining funding pursuant to the Recreational Infrastructure Program in Ontario and Ontario Recreation Program in order to meet capital expenditures in connection with eligible capital projects for such funding by completing and submitting applications through the form provided (the "**Application**");

AND WHEREAS the Municipality has submitted an Application to the Federal and Provincial governments to request funding in respect of the Projects;


NOW THEREFORE the Council of the City of Hamilton enacts as follows:84,220,000

1. The Council of the Municipality hereby confirms, ratifies and approves the completion by the General Manager of Finance and Corporate Services of Applications and the submissions by such authorized official of Applications, duly

executed by such authorized official, to the Federal and Provincial governments for the funding of the Projects in connection with the Recreational Infrastructure Program in Ontario and Ontario Recreation Program in the maximum aggregate principal amount of \$84,220,000 (the "Funding").

2. This By-law takes effect on the day of passing.
