# **CITY OF HAMILTON**

### BY-LAW NO. 09-115

#### To Amend Zoning By-law No. 90-145-Z Respecting Lands Located at 1396 Seaton Road, in the former Town of Flamborough, now in the City of Hamilton

WHEREAS the <u>City of Hamilton Act</u>, <u>1999</u>, Statutes of Ontario, <u>1999</u> Chap. <u>14</u>, Sch. C. did incorporate, as of January 1, 2001, the municipality "City of Hamilton";

**AND WHEREAS** the City of Hamilton is the successor to certain area municipalities, including the former area municipality known as the "The Corporation of the Town of Flamborough" and is the successor to the former Regional Municipality, namely, "The Regional Municipality of Hamilton-Wentworth";

**AND WHEREAS** the <u>City of Hamilton Act, 1999</u>, provides that the Zoning By-laws and Official Plans of the former area municipalities and the Official Plan of the former regional municipality continue in force in the City of Hamilton until subsequently amended or repealed by the Council of the City of Hamilton;

**AND WHEREAS** Zoning By-law No. 90-145-Z (Flamborough) was enacted on the 5<sup>th</sup> day of November 1990, and approved by the Ontario Municipal Board on the 21<sup>st</sup> day of December, 1992;

**AND WHEREAS** the Council of the City of Hamilton, in adopting Item 8 of Report 09-011 of the Economic Development and Planning Committee at its meeting held on the 27th day of May, 2009, recommended that Zoning By-law No. 90-145-Z, be amended as hereinafter provided;

**AND WHEREAS** this By-law is in conformity with the Official Plan of the City of Hamilton (the Official Plan of the former Town of Flamborough), in accordance with the provisions of the <u>Planning Act</u>.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

By-law Respecting 1396 Seaton Road, former Town of Flamborough (Page 2 of 3)

- 1. That Schedule A-25 of Zoning By-law No. 90-145-Z (Flamborough), as amended, is hereby further amended by changing the zoning from the Agricultural "A" Zone to the Agricultural "A-87" Zone, Modified, on the lands the extent and boundaries of which are shown on Schedule "A" annexed hereto and forming part of this By-law.
- 2. That Section 33: Agriculture Zone of Zoning By-law No. 90-145-Z (Flamborough), as amended, is hereby further amended by adding the following subsection:

33.3.87 A-87 (See Schedule A-25)

## Permitted Uses

Notwithstanding the permitted uses of Subsection 33.1, only the following uses shall be permitted:

- (a) Agriculture.
- (b) Conservation.


## Zone Provisions

- 3. That the Clerk is hereby authorized and directed to proceed with the giving of notice of the passing of this by-law, in accordance with the <u>Planning</u> <u>Act.</u>
