CITY OF HAMILTON

BY-LAW NO. 10-020

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

"Kenilworth Ave. Centre on Barton Exit Opposite Vansitmart Ave.	Burlington St. 25m West of Kenilworth Ave.N.	East curb lane 1 st lane from South curb	Anytime	Northerly to Easterly
Centre on Barton Exit Opposite Vansitmart Ave.	25m West of Kenilworth Ave.N.	2nd lane from South curb	Anytime	Easterly to Northerly"

and by deleting from to Section "E" (Hamilton) thereof the following items, namely:

"Northerly Exit Greater Hamilton Shopping Centre	50 ft. west of Kenilworth and Kenilworth	South	Anytime	Easterly to Southerly



2. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "C" (Flamborough) thereof the following item, namely:

"Barton St. Flamboro St. Hamilton St. S. 40 km/h"

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
4. This By-law shall come into force and take effect on the date of its passing and enactment.
