CITY OF HAMILTON

BY-LAW NO. 10-187

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

3. Schedule 8 (No Right Turns) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following item, namely:

"West 5th Street Northbound Claremont Drive Anytime"

and by deleting from Section "G" (Former Regional Roads) thereof the following item, namely:

"Claremont Drive Southwesterly James Mtn. Road Anytime"

4. Schedule 10 (No Left Turns) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following item, namely:

"West 5th Street Southbound Claremont Drive Anytime"

5. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following items, namely:

"Woodward Ave.	59 m north of Melvin to 45 m further north	Centre	Anytime	Northerly to Westerly; and Southerly to Easterly
Woodward Ave.	Vansimart to to 74 m south of Rennie	Centre	Anytime	Northerly to Westerly; and Southerly to Easterly
Woodward Ave.	70 m north of Rennie to 75 m south of Brampton	Centre	Anytime	Northerly to Westerly; and Southerly To Easterly"

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.

7. This By-law shall come into force on the date it is passed.
