BY-LAW NO. 10-304

To Amend Zoning By-law No. 05-200, as Amended, Respecting Lands Located at 1061 Garner Road East, Part of Lots 52 and 53, **Concession 3 (Ancaster)**

WHEREAS the City of Hamilton has in force several Zoning By-laws which apply to the different areas incorporated into the City by virtue of the City of Hamilton Act, 1999, S.O. 1999, Chap 14;

AND WHEREAS the City of Hamilton is the lawful successor to the former Municipalities identified in Section 1.7 of By-law 05-200;

AND WHEREAS Zoning By-law No. 05-200 was enacted on the 25th day of May, 2005;

AND WHEREAS the Council of the City of Hamilton, in adopting Item 25 of Report 10-001 of the Planning Committee, at its meeting held on the 15th day of December, 2010, recommended that Zoning By-law No. 05-200 (Ancaster) be amended as hereinafter provided:

AND WHEREAS the By-law is in conformity with the Official Plan of the City of Hamilton (formerly the Official Plan of the Town of Ancaster) in accordance with the provisions of the Planning Act.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

That Map Nos. 1233, 1285, 1286, and 1339 of Schedule "A" to Zoning By-law No. 1. 05-200, are amended, by incorporating additional Neighbourhood Institutional (I1) Zone, Neighbourhood Park (P1) Zone, and Conservation/Hazard Lands (P5) Zone boundaries for the applicable lands, the lands, the extent and boundaries of which are shown on Schedule "A" annexed hereto and forming part of this Bylaw.


