BY-LAW NO. 11-121

To Amend By-law No. 10-209, a By-law to Regulate the Hamilton Farmers' Market

WHEREAS Council enacted a By-law to regulate the Hamilton Farmers' Market being City of Hamilton By-law No. 10-209;

AND WHEREAS this By-law provides for amendments to the hours for the café in the Hamilton Farmers' Market;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. The definition of "market day" in section 2 of By-law No. 10-209 is deleted and replaced with the following new

"market day" means:

- (i) as it relates to all stallholders but subject to clause (ii), any Tuesday, Thursday, Friday or Saturday, which is not a holiday;
- (ii) as it relates to the stallholder selected by the Market Supervisor to operate a café, any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday, which is not a holiday; and
- (iii) includes any other day, which may from time to time be designated by Council as a market day;

- 2. Subsection 5(1) of By-law No. 10-209 is deleted and replaced with the following new subsections 5(1) and 5(1a):
 - 5(1) Subject to subsection 5(1a), the market hours for customers shall be as follows:
 - (a) From 7:00 in the morning to 6:00 in the afternoon on the same day on Tuesday and Thursday;
 - (b) From 8:00 in the morning to 6:00 in the afternoon of the same day on Friday; and
 - (c) From 6:00 in the morning to 6:00 in the afternoon of the same day on Saturday.
 - 5(1a) The market hours for customers of the stallholder selected by the Market Supervisor for the purpose of operating a café shall be as follows:
 - (a) From 9:00 in the morning to 7:00 in the afternoon on the same day on Monday and Wednesday;
 - (b) From 6:00 in the morning to 7:00 in the afternoon of the same day on Tuesday and Thursday;
 - (c) From 8:00 in the morning to 6:00 in the afternoon of the same day on Friday; and
 - (d) From 6:00 in the morning to 6:00 in the afternoon of the same day on Saturday.

- 3. Subsection 5(2) of By-law No. 10-209 is deleted and replaced with the following new subsections 5(2) and 5(2a):
 - 5(2) Subject to subsection 5(2a), the market hours for stallholders shall be as follows:
 - (a) Except as provided in paragraphs (b), (c) and (d), from 4:00 in the morning to 6:00 in the afternoon of the same day;
 - (b) On Saturdays from 3:00 in the morning to 6:00 in the afternoon of the same day;
 - (c) From 12:00 midnight on market days immediately preceding a statutory holiday to 6:00 in the afternoon of the same day; and
 - (d) During peak season, for such periods of time as are designated by the Market Supervisor.
 - 5(2a) The market hours for the stallholder selected by the Market Supervisor for the purpose of operating a café shall be as follows:
 - (a) Except as provided in paragraphs (b), (c), (d) and (e), from 4:00 in the morning to 9:00 in the evening of the same day;
 - (b) On Fridays from 4:00 in the morning to 8:00 in the evening of the same day;
 - (c) On Saturdays from 3:00 in the morning to 8:00 in the evening of the same day;
 - (d) From 12:00 midnight on market days immediately preceding a statutory holiday to 2 hours after the closing time for customers of the same day; and

- (e) During peak season, for such periods of time as are designated by the Market Supervisor.
- 4. This By-law comes into force on the day it is passed.
