CITY OF HAMILTON

BY-LAW NO. 11-218

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Stop Control) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

and by adding to Section "F" (Stoney Creek) thereof the following items, namely:

“Cornerstone Dr.	Northbound	Old Mud St.
Clement Dr.	Northbound	Old Mud St.
Cedarville Dr.	Northbound	Old Mud St.
Millen Rd.	Southbound	Frances Ave. E. Leg”

and by adding to Section "G" (Former Regional Roads) thereof the following items, namely:

“Barton St. E.	Eastbound/Westbound	Lewis Rd.”

and by removing from Section "E" (Hamilton) thereof the following items, namely:

“Markland St.	Westbound	Park St. S.
Markland St.	Eastbound	Park St. S.
East 26 th St.	Northbound/Southbound	Crockett St.
Crockett St.	Eastbound/Westbound	East 26 th St.
Crockett St.	Eastbound/Westbound	East 26 th St.”

2. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
3. This By-law shall come into force and take effect on the date of its passing and enactment.
