## **CITY OF HAMILTON**

### **BY-LAW NO. 12-071**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"James	Both	Murray to King William	2 hr	\$1.00
James	East	King William to King	30 min	\$1.00
James	East	King to Main	2 hr	\$1.00
James	East	Bold to Charlton	2 hr	\$1.00"

and by adding to Section "E" thereof the following item, namely:

2. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

and by adding to Section "F" thereof the following item, namely:

6. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "F" thereof the following item, namely:

"Fruitland                      Both                      North Service Road to 30m  
northerly                      Anytime"

7. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Strathearne                      West                      from 65.3m south of Britannia  
to 7m southerly                      8:00 a.m. to 8:00 p.m."  
Monday to Friday

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
  
9. This By-law shall come into force and take effect on the date of its passing and enactment.
