CITY OF HAMILTON

BY-LAW NO. 13-047

To Amend Locke Street Business Improvement Area By-law No. 06-309

WHEREAS on October 11, 2006, the Council of the City of Hamilton passed and enacted By-law No. 06-309 respecting the Locke Street Business Improvement Area in accordance with subsection 204(1) of the *Municipal Act, 2001*, c. 25, as amended;

AND WHEREAS pursuant to section 209 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, a municipality may alter the boundaries of an improvement area;

AND WHEREAS on November 28, 2012, the Council of the City of Hamilton approved Item 6 of Report 12-033 of the General Issues Committee, authorizing the expansion of the boundaries of the Locke Street Business Improvement Area;

AND WHEREAS notice of this expansion has been circulated within the boundaries of the Locke Street Business Improvement Area as required pursuant to section 210 of the *Municipal Act, 2001*, S.O. 2001, c. 25, and insufficient objections have been received to prevent passage of this By-law;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. The boundaries of the area designated as the Locke Street Business Improvement Area by By-law 06-309, as amended, and comprised of the Business Improvement Area shown on Appendix "1" are altered by expanding the boundaries to include the area which is comprised of the Proposed Expanded Area as shown on Appendix "1" attached to this By-law.
2. Appendix "1" forms part of this By-law and the notations, references and other information shown on Appendix "1" are as much a part of this By-law as if these notations, references and other information were fully described.

3. Schedule "A" attached to By-law 06-309 is deleted and in its place Appendix "2" attached to this By-law and forming part of it is attached to By-law 06-309 as Schedule "A".
4. This by-law comes into force on the day it is passed.

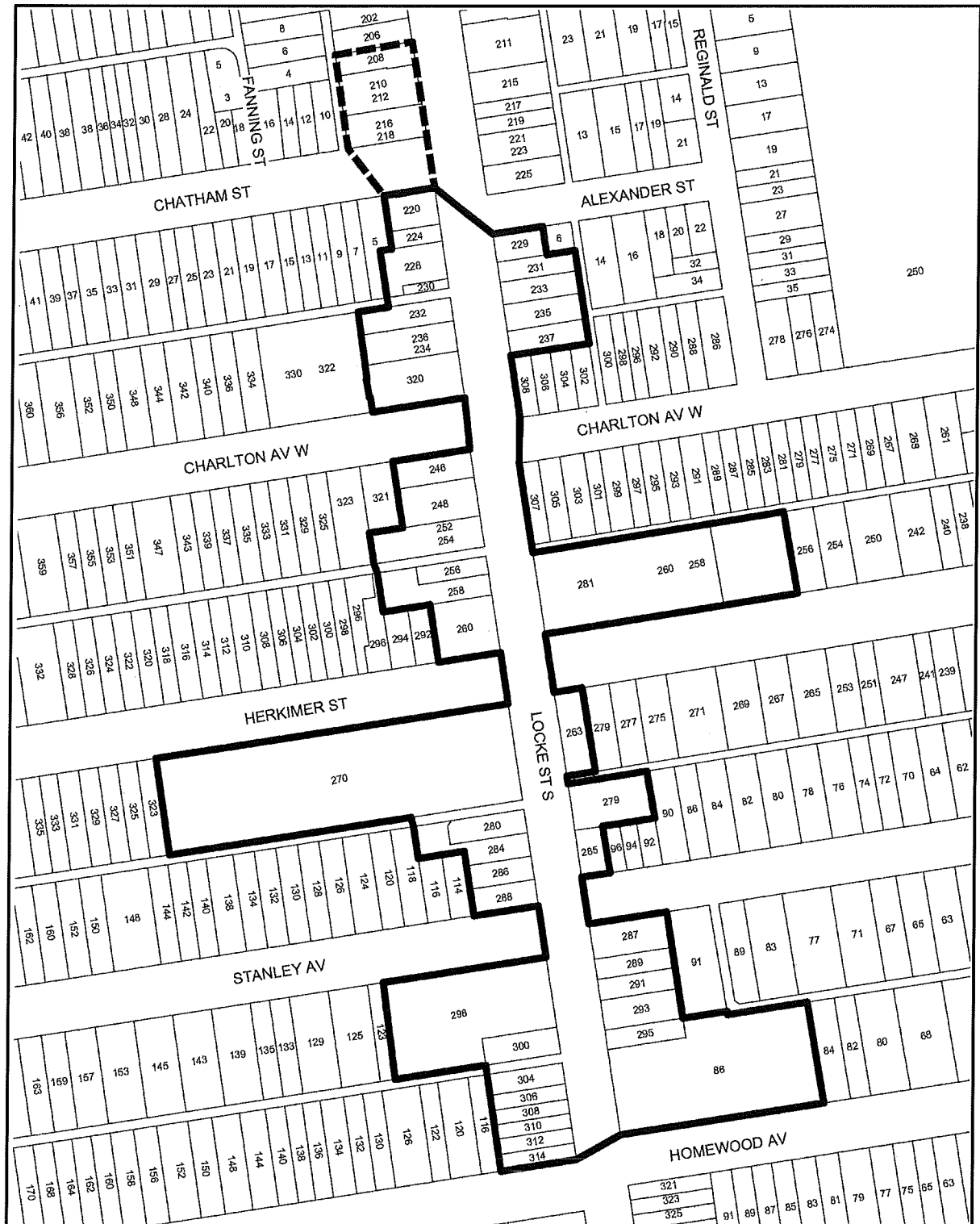

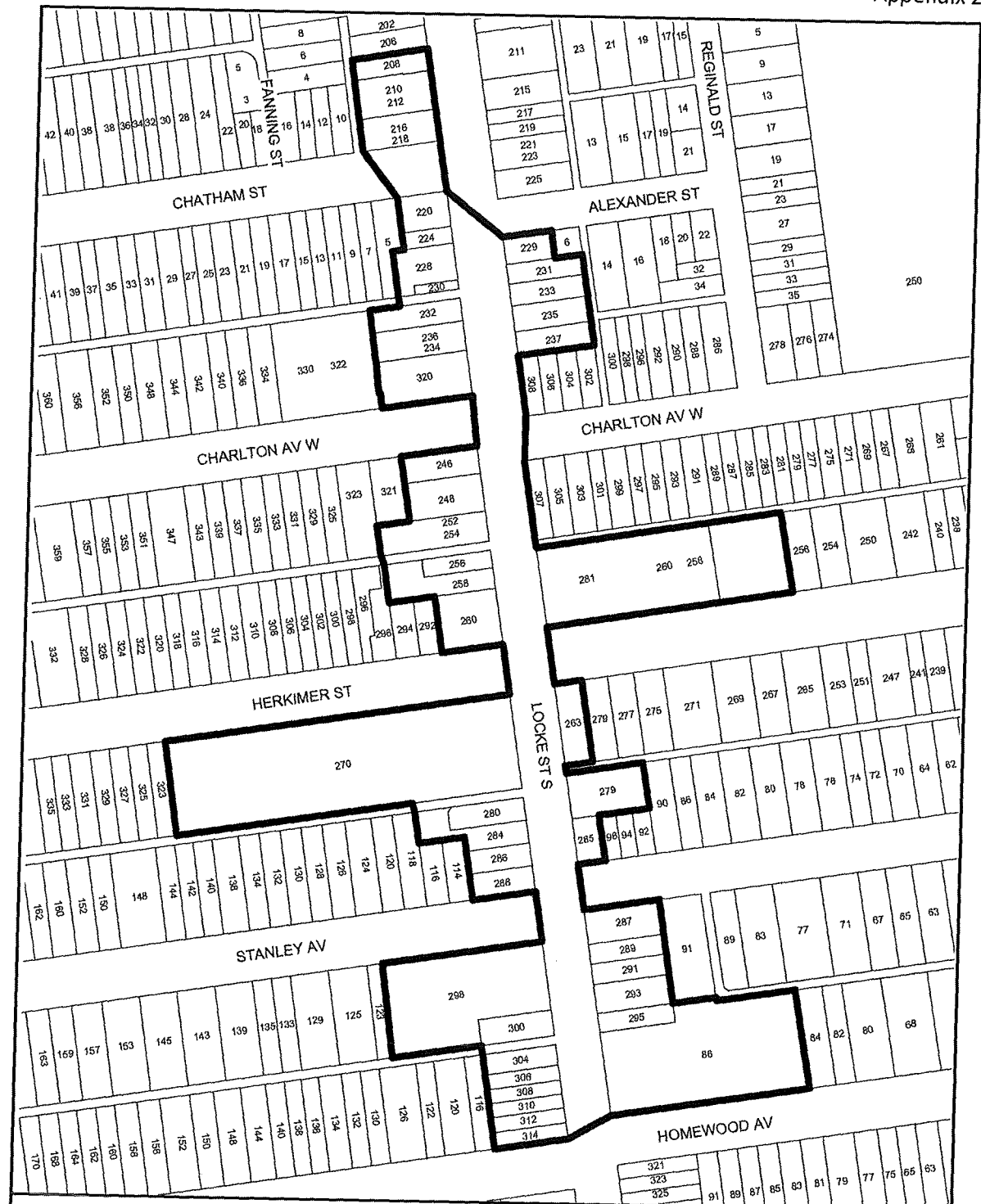
