CITY OF HAMILTON

BY-LAW NO. 13-103

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

"Fairleigh West from 95.9m south of Delaware to 7m southerly 8:00 a.m. to 5:00 p.m." Monday to Friday

and by adding to Section "E" thereof the following item, namely:

"Templemead North from 118m west of the south-east intersection with Mount Pleasant to 5.3m westerly Anytime"

8. Schedule 16 (Taxi Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Wendover South from 91.2m east of Magnolia to 16.5m easterly 7:00 a.m. to 6:00 p.m." Monday to Friday

9. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Wendover South from 24m east of Magnolia to 70m easterly 7:00 a.m. to 6:00 p.m." Monday to Friday

and by adding to Section "E" thereof the following item, namely:

"Wendover South from 25.2m east of Magnolia to 66m easterly 7:00 a.m. to 6:00 p.m." Monday to Friday

and by deleting from Section "F" thereof the following item, namely:

"Winona West 34.8m north of Highway 8 to 100.8m north 7:30 a.m. to 8:15 a.m." 1:45 p.m. to 2:45 p.m.


