## CITY OF HAMILTON

## **BY-LAW No. 13-184**

To Amend Zoning By-law No. 05-200, Respecting Lands Located at 528 Jones Road (Stoney Creek)

**WHEREAS** the City of Hamilton has in force several Zoning By-laws which apply to the different areas incorporated into the City by virtue of the <u>City of Hamilton Act</u>, 1999, S.O. 1999, Chap. 14;

**AND WHEREAS** the City of Hamilton is the lawful successor to the former Municipalities identified in Section 1.7 of By-law No. 05-200;

**AND WHEREAS** it is desirable to enact a new Zoning By-law to comprehensively deal with zoning throughout the City;

**AND WHEREAS** the Council of the City of Hamilton, in adopting Item 8 of Report 13-011 of the Planning Committee, at its meeting held on the 12th day of July, 2013, recommended that Zoning By-law No. 05-200, be amended as hereinafter provided;

**AND WHEREAS** this By-law is in conformity with the Official Plan of the City of Hamilton (the Official Plan of the former City of Stoney Creek);

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

- 1. That Map Nos. 1101 and 1150 of Schedule "A" to Zoning By-law No. 05-200 is amended by incorporating the Conservation/Hazard Land (P5) Zone, on the lands the extent and boundaries of which are shown on a plan hereto annexed as Schedule "A".
- 2. That the Clerk is hereby authorized and directed to proceed with the giving of notice of the passing of this By-law, in accordance with the <u>Planning Act</u>.

3. That this By-law No. **13-184** shall come into force and be deemed to come into force in accordance with Sub-section 34(21) of the <u>Planning Act</u>, either upon the date of passage of this By-law or as otherwise provided by the said Sub-section.


