CITY OF HAMILTON

BY-LAW NO. 13- 243

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (One-Way Streets) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

"Hunter	Westerly	Wellington	Liberty
Hunter	Westerly	Catharine	MacNab
Hunter	Westerly	Queen	Richmond"

And by removing from Section "E" (Hamilton) thereof the following item namely:

"Hunter	Westerly	Wellington	Richmond"

And by adding to Section "G" (Former Regional Roads) thereof the following items namely:

"King	Westerly	Main	Breadalbane
Main	Easterly	Centre line of Paradise	Macklin
Main	Easterly	Hwy 403 eastbound off-ramp	King"

And by removing from Section "G" (Former Regional Roads) thereof the following items namely:

"King	Westerly	Delta	Breadalbane
King	Westerly	Macklin	Centre street line of Paradise
Main	Easterly	Centre line of Paradise	Delta"

2. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

"Hunter	100 ft. east of Queen and MacNab	1st lane from north curb	Anytime	Westbound	
Hunter	100 ft. east of Queen and MacNab	2nd lane from north curb	Anytime	Westbound	
Hunter	Queen and MacNab	2nd lane from south curb (bicycle lane)	Anytime	Westbound	Bicycles only

Hunter	Queen and MacNab	1st lane from the south curb (bicycle lane)	Anytime	Eastbound	Bicycles only
Hunter	Catharine and Liberty	1st lane from north curb	Anytime	Westbound	
Hunter	Catharine and Liberty	2nd lane from north curb	Anytime	Westbound	
Hunter	Catharine and Liberty	2nd lane from south curb (bicycle lane)	Anytime	Westbound	Bicycles only

And by adding to Section "G" (Former Regional Roads) thereof the following items namely:

"King	Hwy 403 on-ramp and Breadalbane	1st lane from the north curb (bicycle lane)	Anytime	Westbound	Bicycles only
King	Hwy 403 on-ramp and Breadalbane	2nd lane from the north curb (bicycle lane)	Anytime	Eastbound	Bicycles only
King	Macklin to 150 ft. east of Paradise	South curb lane	Anytime	Westerly	
King	Macklin to 150 ft. east of Paradise	2nd lane from south curb	Anytime	Westerly	
King	Macklin to Paradise	3rd lane from south curb	Anytime	Westerly	


King	Paradise and 125m east of Macklin	1st lane from the north curb (bicycle lane)	Anytime	Westbound	Bicycles only
King	Paradise and 125m east of Macklin	2nd lane from the north curb (bicycle lane)	Anytime	Eastbound	Bicycles only
Main	Macklin and Hwy 403 off- ramp	1st lane from the south curb (bicycle lane)	Anytime	Eastbound	Bicycles only

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
4. This By-law shall come into force and take effect on the date of its passing and enactment.
