CITY OF HAMILTON

BY-LAW NO. 14-054

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"East 22nd West Crockett to 15.7m southerly 1 hr 8 am – 8 pm Anyday"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Nashville Both from easterly end of Nashville to 23m westerly Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Birch East from 94.5m north of Cannon to 6.1m northerly Anytime"

To Amend By-law No. 01-218, as amended,
Being a By-law to Regulate On-Street Parking

Carrick	West	from 52.8m south of Vineland to 6.2m southerly	Anytime
Charlton	South	commencing 70.7m west of Dundurn and extending 5.8m westerly therefrom	Anytime
Division	East	from 3.2m south of the extended north curb line of Merchison to 6m southerly	Anytime
Fairholt	West	from 62.2m south of King to 4.1m southerly	Anytime
Ruth	East	from 42.6m south of Clinton to 6.1m southerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Carrick	West	from 49.8m north of Dunsmure to 9.5m northerly	Anytime
Carrick	East	From 61.4m north of Dunsmure to 11m northerly	Anytime"

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Mill	South	from 36.5m east of Hess to 4.7m easterly	8:00 a.m. to 5:00 p.m."

and by adding to Section "E" thereof the following items, namely:

"Kentley	North	from 44m east of Nash to 8m easterly	Anytime
Lottridge	East	from 48.2m north of Barton to 10m northerly	Anytime
Niagara	West	from 77.6m south of Brant to 6m southerly	Anytime

Wellington East from 40.7m north of Robert to Anytime”
6m northerly

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
6. This By-law shall come into force and take effect on the date of its passing and enactment.
