CITY OF HAMILTON

BY-LAW NO. 14-133

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

2. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

“Main Both Highway 5 to Griffin 2 hr Anytime Anyday”

and by deleting from Section "E" thereof the following item, namely:

“Afton North Norway to Lorne 2 hr 8 am – 6 pm Mon – Fri”

and by adding to Section "E" thereof the following items, namely:

“Afton North Norway to Lorne 2 hr 8 am – 6 pm Mon – Fri
Apr 1st –
Nov 30th”

Afton South Norway to Lorne 2 hr 8 am – 6 pm Mon – Fri
Dec 1st –
Mar 31st”

3. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "D" thereof the following items, namely:

“Viking North from 30.8m east of Donald Bell to 6m easterly Anytime

Viking South from 25.5m east of the extended east curb line of Donald Bell to 7m easterly Anytime

Windwood North Bradley to 159.2m easterly Anytime”

and by deleting from Section "E" thereof the following item, namely:

“Afton South Lorne to Norway Anytime”

and by adding to Section "E" thereof the following items, namely:

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:


“Province West from 45.2m south of Central to 8:00 a.m. to 6:00 p.m.”
5m southerly

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
