CITY OF HAMILTON

BY-LAW NO. 14-187

To Amend By-law No. 01-215 Being a By-law To Regulate Traffic

WHEREAS on September 18, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS on May 22, 2013, the Council of the City of Hamilton approved Item 5 of the Public Works Committee Report 13-006, authorizing modifications to By-law No. 01-215 to regulate traffic as required, to implement the planned A & B Line Passenger Amenities and King Street Bus Only;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Section 18 (Designated Traffic Lanes) of Bylaw No. 01-215 is further amended by deleting subsection (3):

"(3) No person operating a vehicle, except a bus or an authorized emergency vehicle, shall use a transit only lane unless the person is:

(i) immediately turning right at a designated intersection;

(ii) immediately entering or exiting a driveway;

(iii) immediately entering or exiting a parking space;

(iv) operating a taxicab and immediately entering or exiting for the purpose of

receiving or discharging passengers; or

(v) operating a specialized transit vehicle and immediately entering or exiting for

the purpose of receiving or discharging passengers."

And by adding to Section 18 (Designated Traffic Lanes) the following subsection (3):

- "(3) No person operating a vehicle, except a bus or an authorized emergency vehicle or a specialized transit vehicle, shall use a transit only lane unless the person is:
 - (i) immediately turning right at a designated intersection;
 - (ii) immediately entering or exiting a driveway;
 - (iii) immediately entering or exiting a parking space; or
 - (iv) operating a taxicab and immediately entering or exiting for the purpose

of receiving or discharging passengers."

2. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "G" (Former Regional Roads) thereof the following items, namely:
