BY-LAW NO. 14-217

To Amend By-law No. 01-215 Being a By-law To Regulate Traffic

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "G" (Former Regional Roads) thereof the following item, namely:

"Dundurn	100 ft. north of Main	2nd lane west of	Anytime	Southerly and

				Easterly"

And by adding to Section "G" (Former Regional Roads) thereof the following items, namely;

Nebo Rd.	80 m south of Twenty Rd. to 290m south of Twenty Rd.	Centre	Anytime	Northerly to Westerly & Southerly to Easterly
Twenty Rd.	60 m west of Dartnall Rd. to 260 m west of Dartnall Rd.	Centre	Anytime	Easterly to Northerly & Westerly to Southerly"

2. Schedule 18 (Bicycle Lanes) of By-law No. 01-215, as amended, is hereby further amended by removing the following items, namely:

"Twenty Road	Nebo Rd to 345m east of Nebo Rd	North curb lane	Anytime	Westbound
Twenty Road	Nebo Rd to 345m east of Nebo Rd	South curb lane	Anytime	Eastbound"

And by adding to Schedule 18 (Bicycle Lanes) thereof the following items, namely:

"Twenty Rd.	Nebo Rd. to Glover Rd.	North curb lane	Anytime	Westbound
Twenty Rd.	Nebo Rd. to Glover Rd.	South curb lane	Anytime	Eastbound"
