**CITY OF HAMILTON**

**BY-LAW NO. 14-218**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (One-Way Streets) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "G" (Former Regional Roads) thereof the following item, namely:

"Cannon                                      Westerly                                      Sherman                                      York"

And by adding to Section "G" (Former Regional Roads) thereof the following item, namely:

"Cannon St.                                      Westerly                                      Hess St.                                      Queen St."

2. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "G" (Former Regional Roads) thereof the following item, namely:

"Sherman Cannon and Cannon	100 ft. south of and Easterly	2nd lane from east curb	Anytime	Northerly at Northerly"

3. Schedule 18 (Bicycle Lanes) of By-law No. 01-215, as amended, is hereby further amended by removing the following items, namely:

"Wellington St.	Hunter St. to Young St.	East curb lane	Anytime	Northbound
Wellington St.	Hunter St. to Young St.	West curb lane	Anytime	Southbound"


And by adding to Schedule 18 (Bicycle Lanes) thereof the following items, namely:


"Cannon St.	15m east of Sherman Ave. to Sherman Ave.	3 <sup>rd</sup> lane from north curb	Anytime	Westbound
Cannon St.	Hess St. to Sherman Ave.	2 <sup>nd</sup> lane from south curb	Anytime	Westbound
Cannon St.	Hess St. to Sherman Ave.	South curb lane	Anytime	Eastbound

Cannon St.	Queen St. to Hess St.	North curb lane	Anytime	Westbound

4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
5. This By-law shall come into force and take effect on the date of its passing and enactment.
