CITY OF HAMILTON

BY-LAW NO. 15-023

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Cameron West Main to 29m southerly 1 hr \$1.00"

and by adding Section "E" thereof the following item, namely:

"Cameron West Main to 22.3m southerly 1 hr \$1.00"

2. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Fieldway Both Blackthorne to 2 hr 9 am – 5 pm Mon – Fri"

3. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following items, namely:

"Emick	South	from 29.8m west of the extended west curb line of the eastern intersection with Ohara to 28.4m westerly	Anytime

Emick	South & West	from 85.5m west of the extended west curb line of the eastern intersection with Ohara to 24.6m westerly and northerly along the curb line	Anytime"

5. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

6. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:


“Harvey	North	22 feet	290 feet east of Sanford	8:00 am – 5:00 pm
Minto	East	from 56.6m south of Barton to 6.6m southerly		8:00 a.m. to 7:00 p.m.” Monday to Saturday


and by adding to Section "E" thereof the following item, namely:

“East 6th West from 65m north of Fennell to 8.3m northerly Anytime”

7. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
8. This By-law shall come into force and take effect on the date of its passing and enactment.
