**CITY OF HAMILTON**

**BY-LAW NO. 15-039**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 10 (No Left Turn) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "D" (Glanbrook) thereof the following items, namely:

"Rymal Road	Westerly	Entrance to 1970 Rymal Road East	Anytime
Exit from 1970 Rymal Road East	Northerly	Rymal Road	Anytime"

2. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following item, namely:

"Centennial Parkway	50 m north of Violet Drive to Eastgate Court	Centre Lane	Anytime	Southerly to Easterly and Northerly to Westerly"


And by adding to Section "F" (Former Regional Roads) thereof the following items, namely:


"Governors Road	56 m west of Highway 52 to Highway 52	Curb lane	Anytime	Easterly to southerly
Governors Road	56 m west of Highway 52 to Highway 52	2 <sup>nd</sup> lane from south curb	Anytime	Easterly and Easterly to Northerly
Governors Road	55 m east of Highway 52 to Highway 52	Curb lane	Anytime	Westerly to Northerly
Governors Road	55 m east of Highway 52 to Highway 52	2 <sup>nd</sup> lane from north curb	Anytime	Westerly and Westerly to Southerly
Highway 52	200 m north of Governors Road to Governors Road	Curb lane	Anytime	Southerly to Westerly
Highway 52	200 m north of Governors Road to Governors Road	2 <sup>nd</sup> lane from west curb	Anytime	Southerly and Southerly to Easterly
Highway 52	110 m south of Governors Road to Governors Road	Curb lane	Anytime	Northerly to Easterly

Highway 52	110 m south of Governors Road to Governors Road	2 <sup>nd</sup> lane from east curb	Anytime	Northerly and Northerly to Westerly"

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
4. This By-law shall come into force and take effect on the date of its passing and enactment.
