CITY OF HAMILTON

BY-LAW NO. 15-093

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Right Turn) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following item, namely:

"Fennell Avenue	Easterly	100m west of West 5 th St. (Mohawk College Transit Terminal exit)	Anytime"

2. Schedule 10 (No Left Turn) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following item, namely:

"Fennell Avenue	Westerly	100m west of West 5 th St. (Mohawk College Transit Terminal exit)	Anytime"

3. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "D" (Glanbrook) thereof the following items, namely:

"Dartnall Rd.	50m south of Rymal Rd. to Rymal Rd.	East curb lane	Anytime	Northerly to Easterly
Dakota Blvd.	Rymal Rd. to 60m southerly	2 nd lane from east curb	Anytime	Northerly to Westerly"

And by adding to Section "D" (Glanbrook) thereof the following item, namely;

"Rymal Road	Nebo Road to 150m west of Dartnall Road	Centre lane	Anytime	Westerly to Southerly and Easterly to Northerly"

And by removing from Section "E" (Hamilton) thereof the following item, namely;

"Rymal Road	49m east of Fletcher to 87m easterly	Centre	Anytime	Easterly to Northerly and Westerly to Southerly"

And by adding to Section "E" (Hamilton) thereof the following item, namely;

"Gage Avenue	Main Street	2 nd lane from east curb	Anytime	Northerly to Westerly"

Rymal	Nebo Road to Dartnall Road	centre lane	Anytime	Westerly to Southerly and Easterly to Northerly
Rymal Rd.	80m east of Glover Rd. 77m west of Pritchard Rd.	Centre Lane	Anytime	Easterly to Northerly and Westerly to Southerly


West 5 th	200 ft. north of Fennell and Fennell	3rd lane from west curb	Anytime

And by adding to Section "G" (Former Regional Roads) thereof the following items, namely;


"King Street	New Mountain Road and 55m easterly	2 nd lane from north curb	Anytime	Westerly to Southerly
Rymal Road	190m east of Dartnall Road to 85m west of Glover Road	Centre	Anytime	Easterly to Southerly and Westerly to Northerly
Rymal Road	90m east of Glover Road to 85m west of Pritchard Road	Centre	Anytime	Easterly to Southerly and Westerly to Northerly
Rymal Road	35m east of Pritchard Road to 110m east of Pritchard Road	Centre	Anytime	Easterly to Southerly and Westerly to Northerly
Rymal Road	95m east of Trinity Church Road to 50m west of Dakota Boulevard	Centre	Anytime	Easterly to Southerly and Westerly to Northerly
Rymal Road	70m east of Dakota Boulevard to 55m west of Fletcher Road	Centre	Anytime	Easterly to Southerly and Westerly to Northerly
Rymal Road	70m east of Fletcher Road to 150m east of Fletcher Road	Centre	Anytime	Easterly to Southerly and Westerly to Northerly
West 5 th Street	Gateview Drive and 20m southerly	East curb lane	Anytime	Southerly to Easterly"

4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
5. This By-law shall come into force and take effect on the date of its passing and enactment.
