## **CITY OF HAMILTON**

### **BY-LAW NO. 15-135**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

"Milverton	East & North	from 60.4m south of Niska to 22.3m southerly	Anytime"
------------	-----------------	---	----------

and by deleting from Section "E" thereof the following item, namely:

"James	East	from 50.4m north of Cannon to 13.7m northerly	Anytime"
--------	------	--	----------

and by adding to Section "E" thereof the following item, namely:

"Beaucort	South	Lower Horning to easterly end, including the cul-de-sac	Anytime"

and by adding to Section "F" thereof the following items, namely:

"Greening	East	MacIntosh to northern intersection with Juniper	Anytime
Greening	West	MacIntosh to 21m southerly	Anytime
Regalview	West	from 50.4m south of Highway 8 to 7m southerly	Anytime"

and by adding to Section "G" (Loading Zones) thereof the following item, namely:

"James	East	from 50.4m north of Cannon to 13.7m northerly	Anytime"

2. Schedule 9 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "F" thereof the following item, namely:

"Kilbourn Avenue	Highway 8 to 15m north of Memorial	East	West"

and by adding to Section "F" thereof the following item, namely:

"Kilbourn	Highway 8 to Memorial	East	West"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "Baker" thereof the following items, namely:

"Baker	North	from 30m west of Breadalbane to 5.7m westerly	Anytime
Locke	East	from 30.2m north of York to 6m northerly	Anytime
Market	North	from 7.4m east of Queen to 91.8m easterly	Anytime
Mary	East	commencing 91 feet south of Picton and extending 20 feet southerly therefrom	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Locke	East	from 38.7m north of York to 5.8m northerly	Anytime
Market	North	Queen to Hess	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Bold	South	from 31.9m east of Bay to 30.4m easterly	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Guildwood	West	from 82.9m south of Trevi to 68.8m southerly	8:00 a.m. to 10:00 a.m. 2:00 p.m. to 4:00 p.m. Monday to Saturday

and by deleting from Section "F" thereof the following item, namely:

"Kilbourn Avenue	East	From Memorial Avenue to a point 100m south	8:30 a.m. - 4:30 p.m." Monday – Friday Holidays Excepted
------------------	------	--	--

and by adding to Section "F" thereof the following items, namely:

"Kilbourn	East	Memorial to 100m southerly	8:00 a.m. to 4:00 p.m. Monday to Friday
Kilbourn	West	Memorial to 25m northerly	Anytime
Kilbourn	East	from 20m north of Memorial to 16m south of Memorial	Anytime"

5. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "F" thereof the following item, namely:


"Kilbourn Avenue	West	From 15m south of Memorial Avenue to 100m south of Memorial Avenue	8:00 am – 9:00 am" 11:30 am – 1:00 pm 3:15 pm – 4:15 pm

and by adding to Section "E" thereof the following item, namely:

"Kilbourn	West	Memorial to 115m southerly	8:00 a.m. to 4:00 p.m." Monday to Friday
-----------	------	----------------------------	---

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
