CITY OF HAMILTON

BY-LAW NO. 15-145

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:
"Prospect Both Afton to Cumberland 2 hr Anytime Anyday"
2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:
"Grant West Stinson to Alanson Anytime"
3. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Grant Avenue	Stinson Street to Main Street East	West	East
Grant Avenue	Main Street to King Street	East	West"

and by adding to Section "E" thereof the following items, namely:

"Grant	Stinson to Main	West	East
Grant	Main to King	East	West"

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Robins	East	from 42m north of Britannia to 6.2m northerly	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Hunter	North	from 51.1m west of Poulette to 6m westerly	Anytime"

5. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Grant	West	9.1m	20.5m south of Stinson	2:30 p.m. – 5:00 p.m."

6. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:




