## **CITY OF HAMILTON**

### **BY-LAW NO. 16-078**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*,

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Sherman	West	Case to Princess	3 hr	8 am – 6 pm	Mon – Sat
Sherman	West	Barton to Princess	2 hr	8 am – 6 pm	Mon – Sat"

and by adding to Section "E" thereof the following item, namely:

"Sherman	West	Barton to Princess	3 hr	8 am – 6 pm	Mon – Sat"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

To Amend By-law No. 01-218, as amended,  
Being a By-law to Regulate On-Street Parking

"Gaines	South	from 21.9m east of the western intersection with Davidson to 7m easterly	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Fortissimo	East & South	from 58.1m north of the northern intersection with Connell to 20.5m northerly and easterly along the curb line	Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Burton	South	from 39.1m east of Emerald to 6m easterly	Anytime
Grosvenor	West	from 73.6m north of Dunsmure to 6m northerly	Anytime
Mars	South	from 24.8m east of Emerald to 5.3m easterly	Anytime
Picton	North	From 33.7m east of Ferguson to 6.8m easterly	Anytime
Stirton	West	from 34.7m north of King to 5m northerly	Anytime
Stirton	East	from 39.6m north of King to 5m northerly	Anytime"

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

To Amend By-law No. 01-218, as amended,  
Being a By-law to Regulate On-Street Parking

(Page 3 of 3)

“West	East	from 50.6m south of Wilson to 6.5m southerly	Anytime”

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
